Significant Activity: Nov 27 – 28



Significant Events: Winter Storm – Eastern US (Final)

Tropical Activity:

- Atlantic Area 1 (Low chance/20%)
- Eastern Pacific Tropical cyclone activity not expected next 48 hours
- Central Pacific No tropical cyclones expected through late Friday night
- Western Pacific No activity threatening U.S. territories

Significant Weather:

- Heavy snow possible Great Lakes
- Snow Upper Mississippi Valley to Northeast
- Rain and snow mix Pacific Northwest to Northern Plains
- Critical Fire Weather Areas/Red Flag Warnings: None
- Space Weather: No space weather storms observed or predicted

Earthquake Activity: None

Declaration Activity: Amendment No.1 to FEMA-4152-DR-NM

Winter Storm – Eastern US (Final)

November 26-28, 2013:


- Strong winter storm moved through eastern seaboard
- Brought heavy rain/snow, wintry mix, strong winds and tornadoes
- Two confirmed tornados in NC (preliminarily assessed EF-2 & EF-1)

Impacts:

- Power outages (downed trees/power lines) & limited property damage
 - o Power restored to most customers; sporadic outages remain
 - Down from peak of 95,000 (NH-50k; MA-20k; NY-25k)
- <u>North Carolina</u> (Carteret County)
 - o Isolated wind/tornado damage to homes, a community college and hospital
 - o 12 minor injuries in Morehead City (est. pop. 8,661)


Response:

- All FEMA Regions remain at Watch/Steady State
- EOCs in TN & VA remain Partially Activated
- All other EOCs remain at—or have returned to—Normal Operations
- No shortfalls and no requests for FEMA assistance



Atlantic – Tropical Outlook






Atlantic – Area 1

- Could gradually acquire subtropical characteristics this weekend

 - Next 48 hours: Low chance (20%)
 - Next 5 days: Medium chance (30%)






Eastern Pacific – Tropical Outlook






Central Pacific – Tropical Outlook






National Weather Forecast








Precipitation Forecast – 3 Day






River Forecast – 7 Day






Convective Outlooks Days 1 – 3






Critical Fire Weather Areas Days 1 – 8







