#### Winter Storm – Midwest to Northeast

## FEMA

#### Situation (January 5 -7)

- ▲ The dangerously cold air mass over the Midwest has begun to impact the Eastern Seaboard
- ▲ This morning, temperatures fell below freezing along the Gulf Coast from eastern TX to western FL
- ▲ Across the Midwest and East Coast, temperatures are expected to improve Wednesday

#### **Impacts**


- ▲ No significant impacts associated with security, water or telecommunications have been reported
- ▲ Fatalities/injuries: IL 1/25; IN 1/0; some media reporting up to 15 fatalities
- ▲ As of 7:30 a.m. EST, approximately 142K customers without power FEMA Regions I-V
  - ▲ Region IV 83K (NC 48K); Region V 30K DOE Eagle I System
- ▲ Many interstates/roads remain closed across multiple states
- ▲ Over 4,000 flights cancelled & 1,800 delayed; rail, and highway delays also reported
- Numerous school districts, state and county governments closed today

#### State Response

- ▲ MD, WV, PA, IL, IN, NY & MI SEOCs Partially Activated; all other SEOCs at Normal Operations
- ▲ Approximately 100 Shelters open with 940 occupants across the Eastern U.S.
- ▲ State and city warming centers are open across numerous states
- ▲ States of Emergency/Snow EM/State Disaster declared: NY, IN, OH & IL
- · No requests for FEMA assistance

#### FEMA Response

- All FEMA Regions remain at Watch/Steady State
- NRCC is not activated; the FEMA NWC remains at Watch/Steady State





## Precipitation Forecast – 3 Day








## Freezing Rain Probabilities (72 Hour)


### River Forecast – 7 Day






## Convective Outlooks Days 1-3






#### Critical Fire Weather Areas Days 1 - 8




