- None





Daily Trends of COVID-19 Cases




Daily Trends of COVID-19 Deaths



National Inpatient Beds Used – COVID-19 Patients

Key Updates:

- U.S. COVID-19 totals:
 - Confirmed Cases: **28,355,420 (+427,863)**
 - Confirmed Deaths: **510,777 (+14,665)**
- Major Disaster Declarations: 58 Emergency Declarations: 43
- Public Assistance obligated for COVID-19 Response: **\$15.3 billion (+400M)**
- FEMA NRCC activated to Level I in support of COVID-19 operations



State Representative Estimates for % of Inpatient Beds Occupied by COVID-19 Patients


- 0 - 4.9%






Key Updates:



National Weather Forecast



Precipitation & Excessive Rainfall




