



- 800 miles SSE of southern tip of Baja California peninsula, Mexico
- Moving W to WNW at 10-15 mph
- Tropical depression likely to form in a couple of days
- 48-hour formation chance: Medium (60%)
- 5-day Formation chance: High (80%)

### Disturbance 2 (as of 8:00 a.m. ET)

- Forecast to develop S or SW of the Gulf of Tehuantepec
- Moving W at 10-15 mph
- Tropical depression likely to form by this weekend
- 48-hour formation chance: Low (near 0%)
- 5-day Formation chance: High (70%)




### Disturbance 1 (as of 8:00 a.m. ET)


# Precipitation & Excessive Rainfall


# Severe Weather Outlook







# FEMA Common Operating Picture










