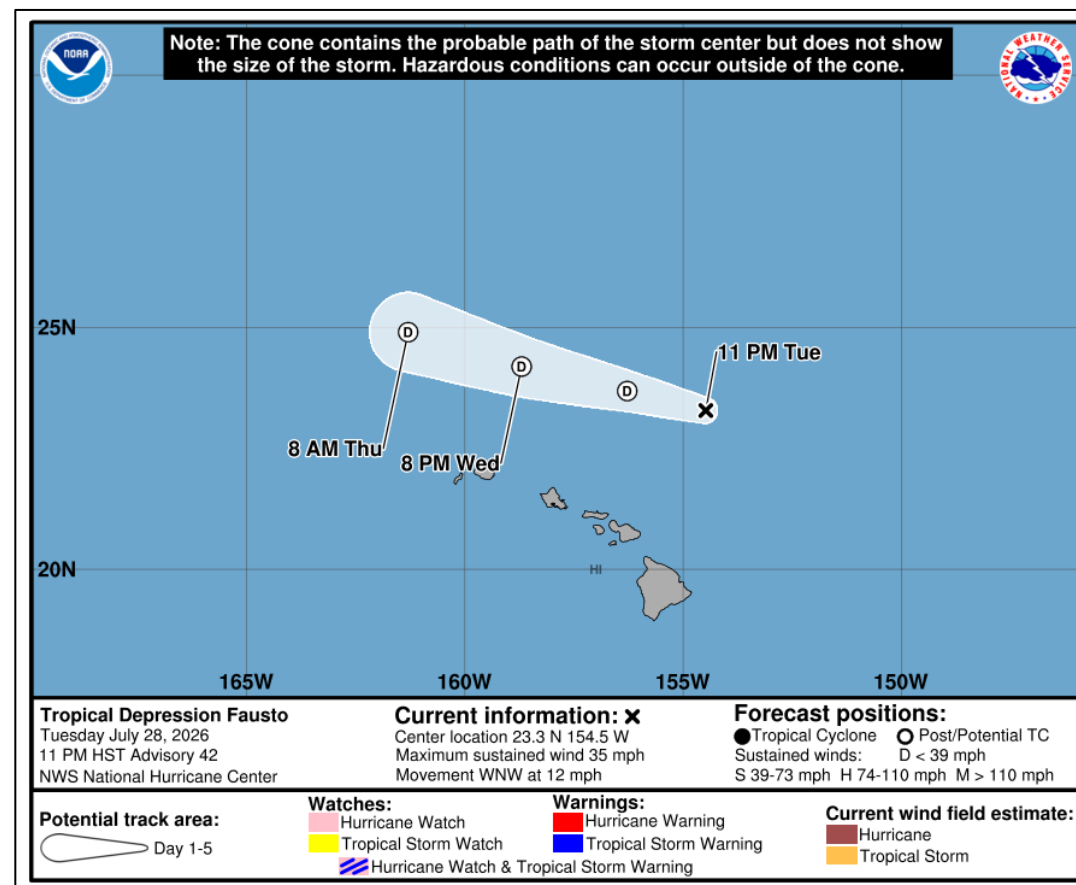

Tropical Depression Fausto – Eastern and Central Pacific

Situation: (Advisory #42, as of 5:00 a.m. ET)

- Located 255 miles ENE of Honolulu, Hawaii
- Moving WNW at 12 mph
- Maximum sustained winds of 35 mph
- Expected to become a post-tropical remnant low today



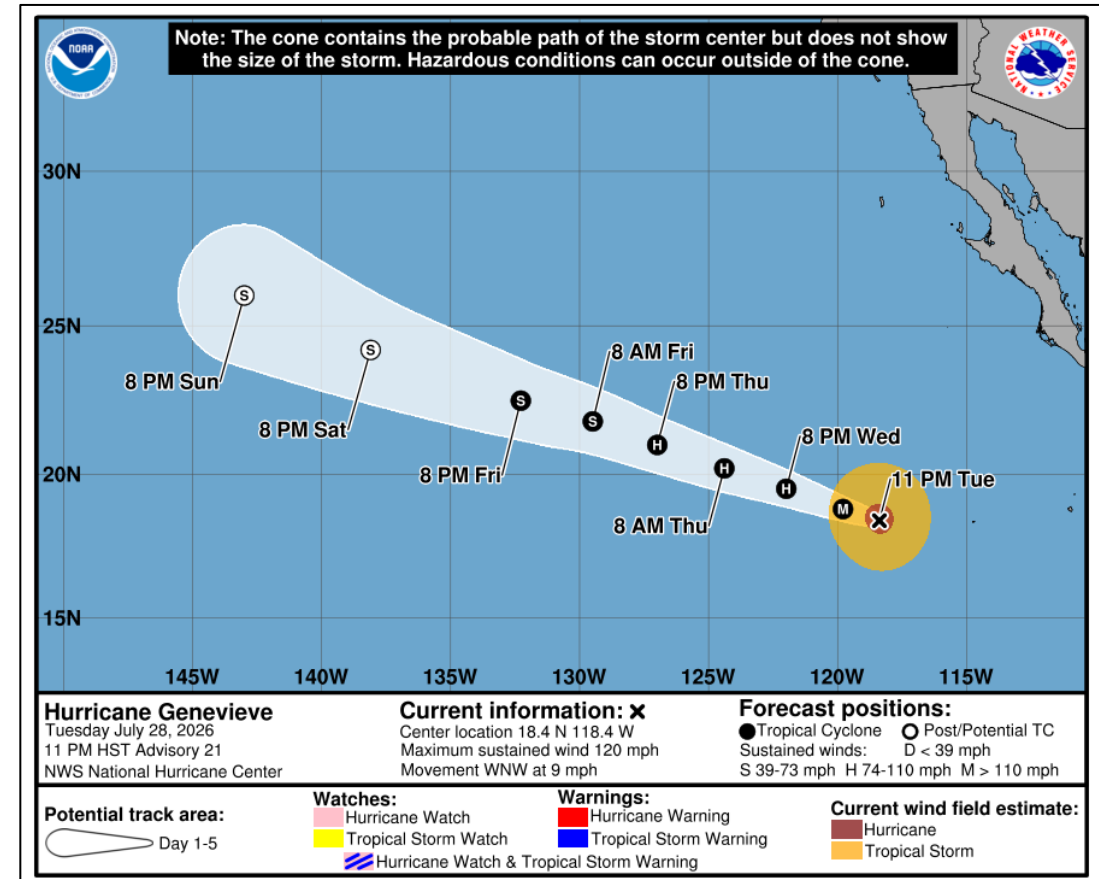

Hurricane Genevieve (CAT-3) – Eastern and Central Pacific

Situation: (Advisory #21, as of 5:00 a.m. ET)

- Located **630** miles **WSW** of the southern tip of Baja California
- Moving **WNW** at **9** mph
- Maximum sustained winds of **120** mph
- Hurricane-force winds extend outward up to **40** miles; tropical-storm-force winds extend outward up to **140** miles
- **Some weakening is expected during the next few days**
- **Forecast to remain a hurricane through Thursday night or early Friday.**

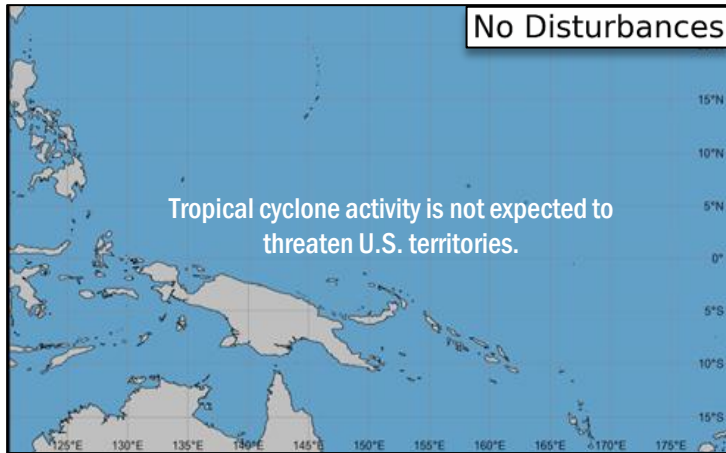

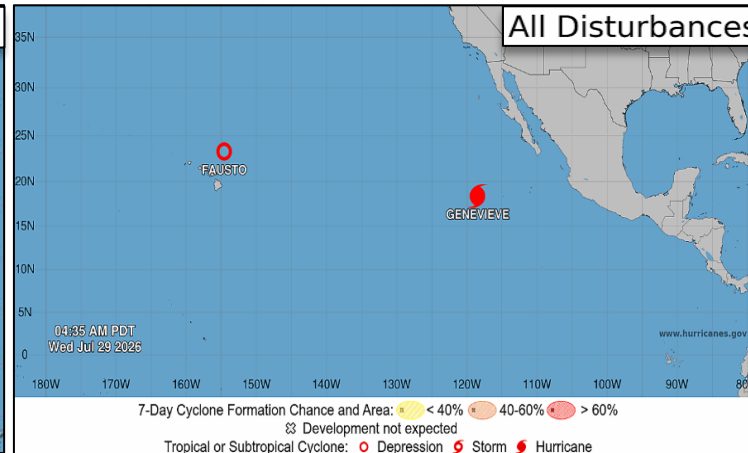

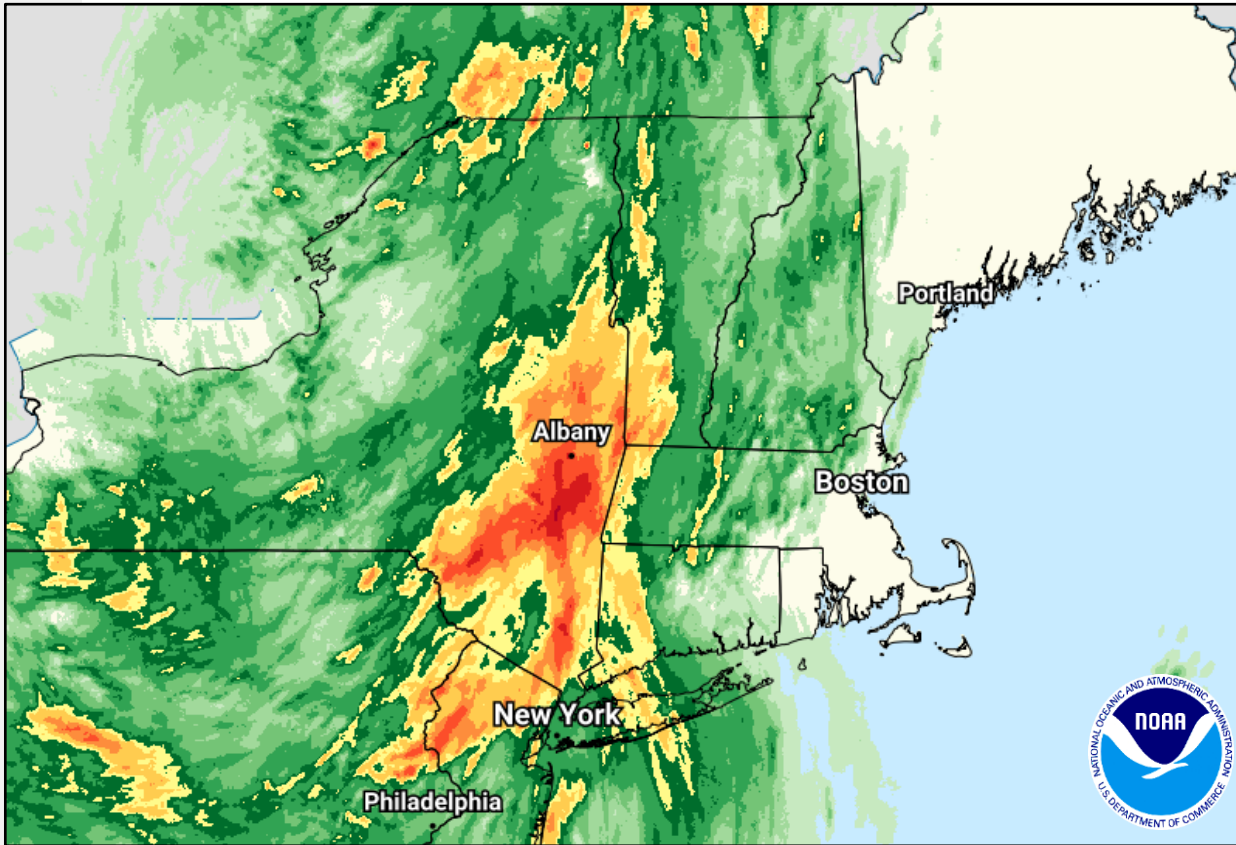

Northeast Heavy Rain



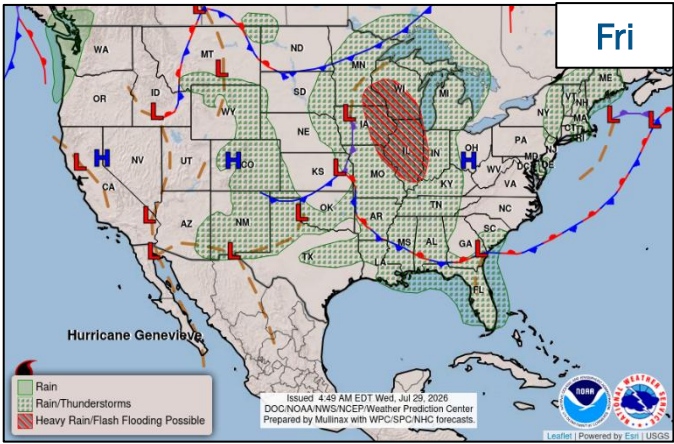
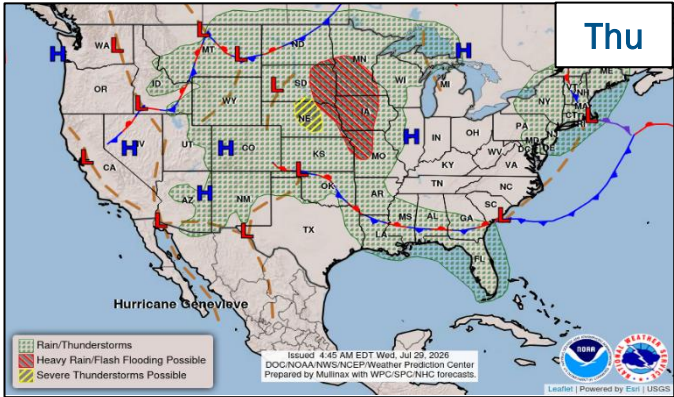
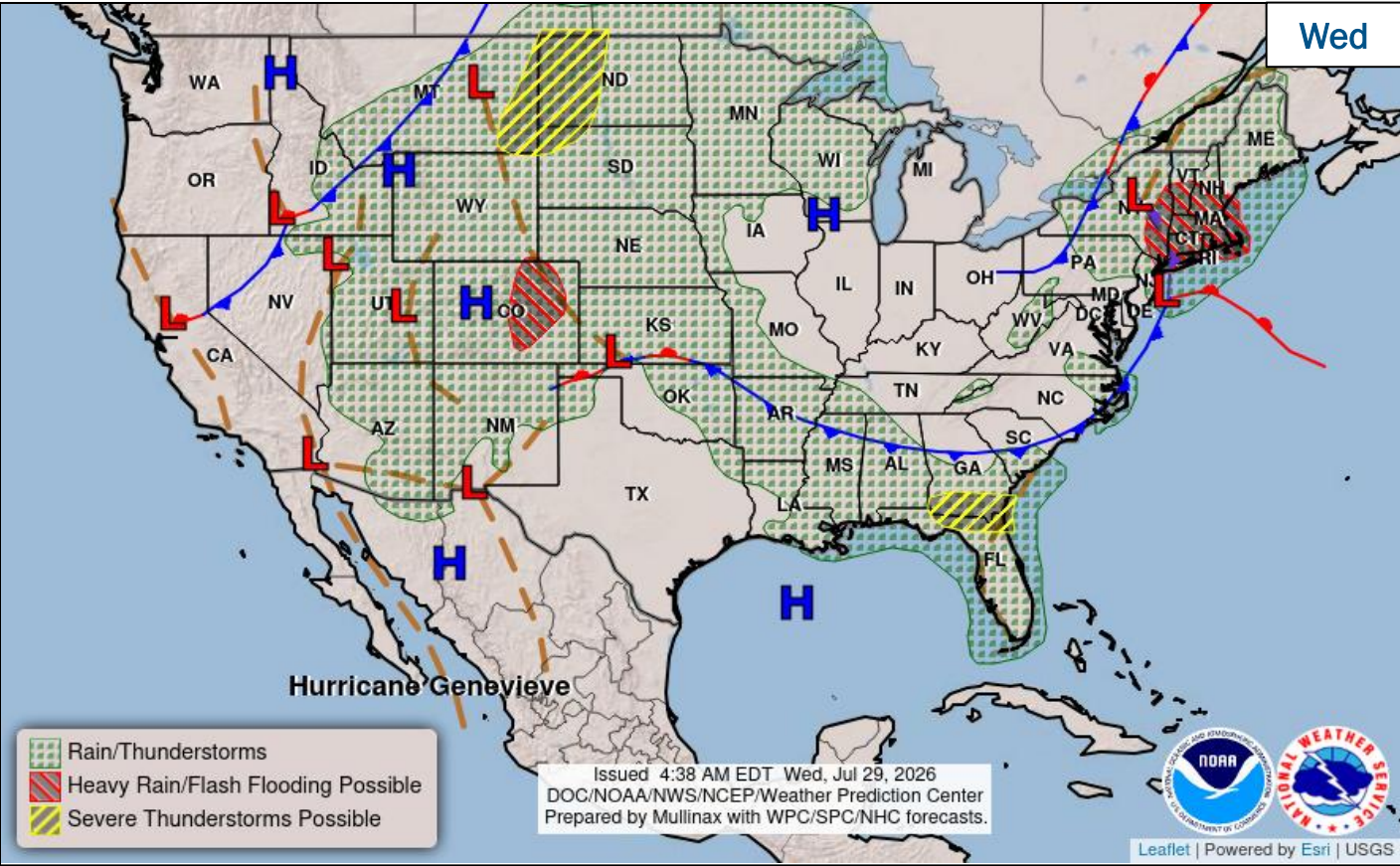
Rainfall Received Over Last 24 Hours

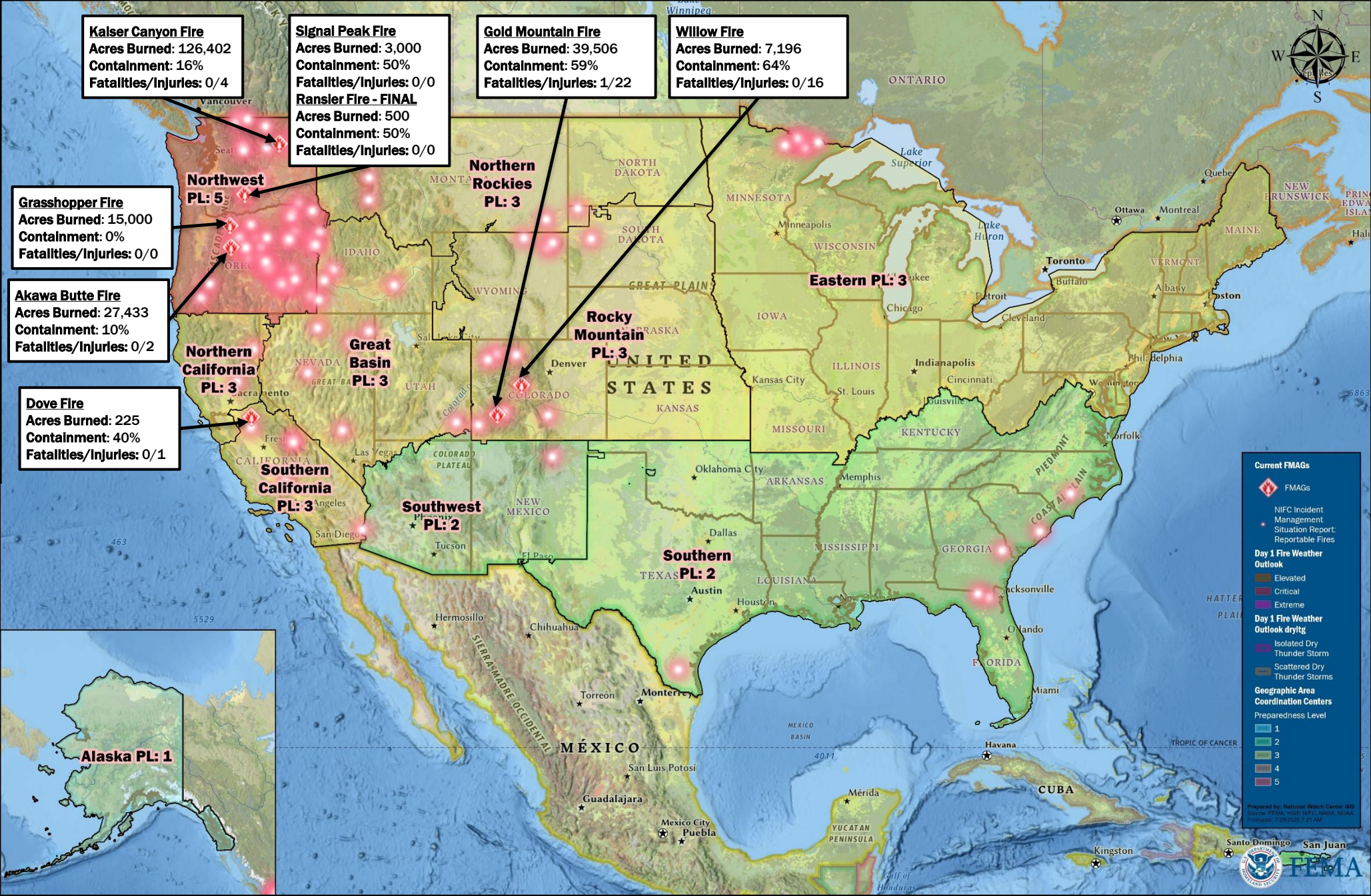

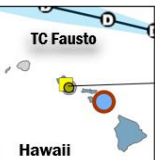

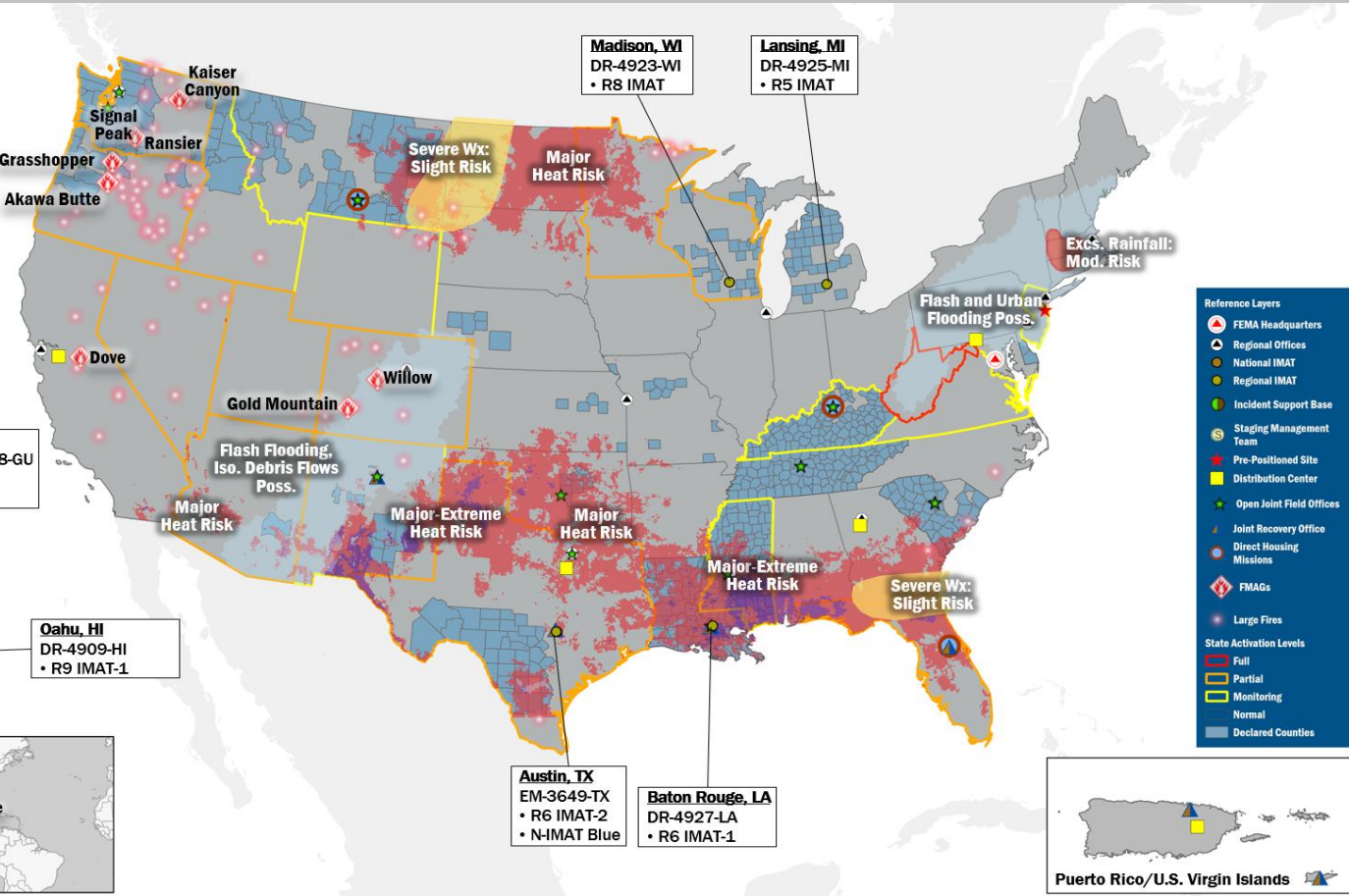
