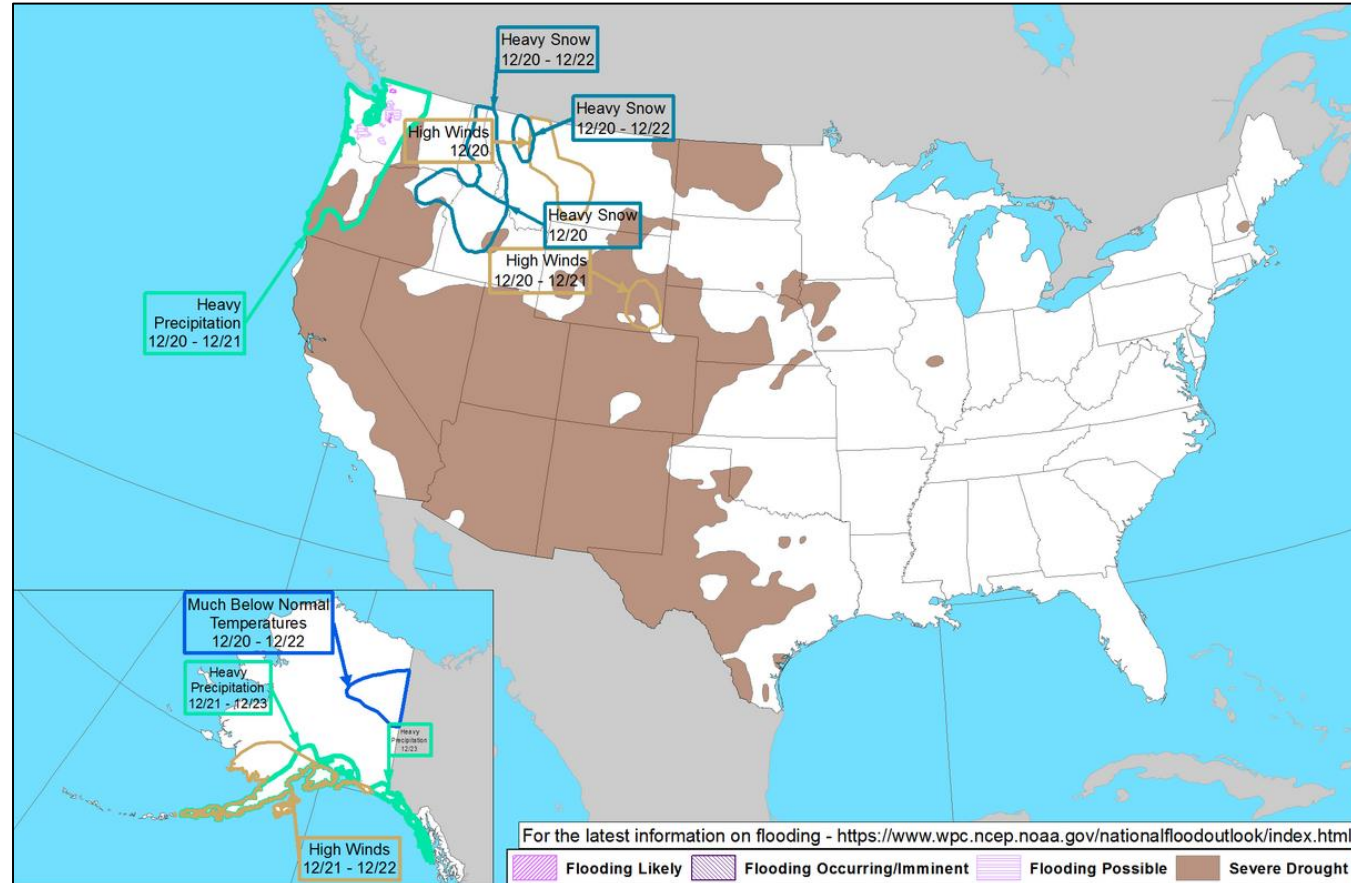
# Forecast Snowfall

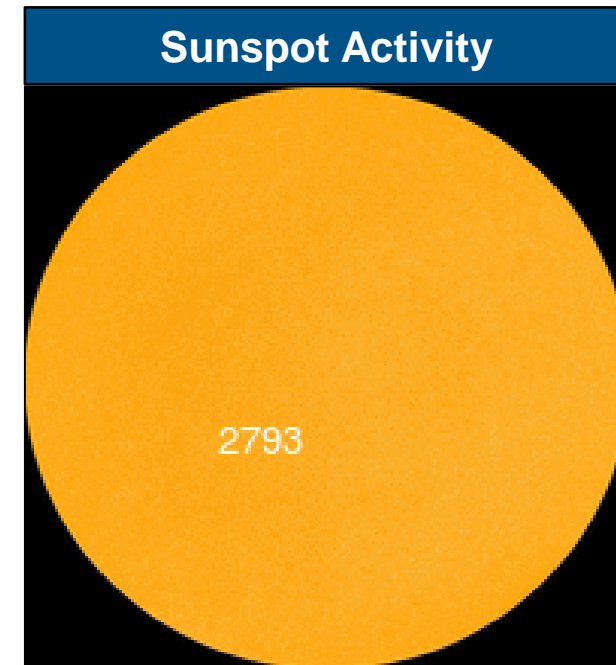
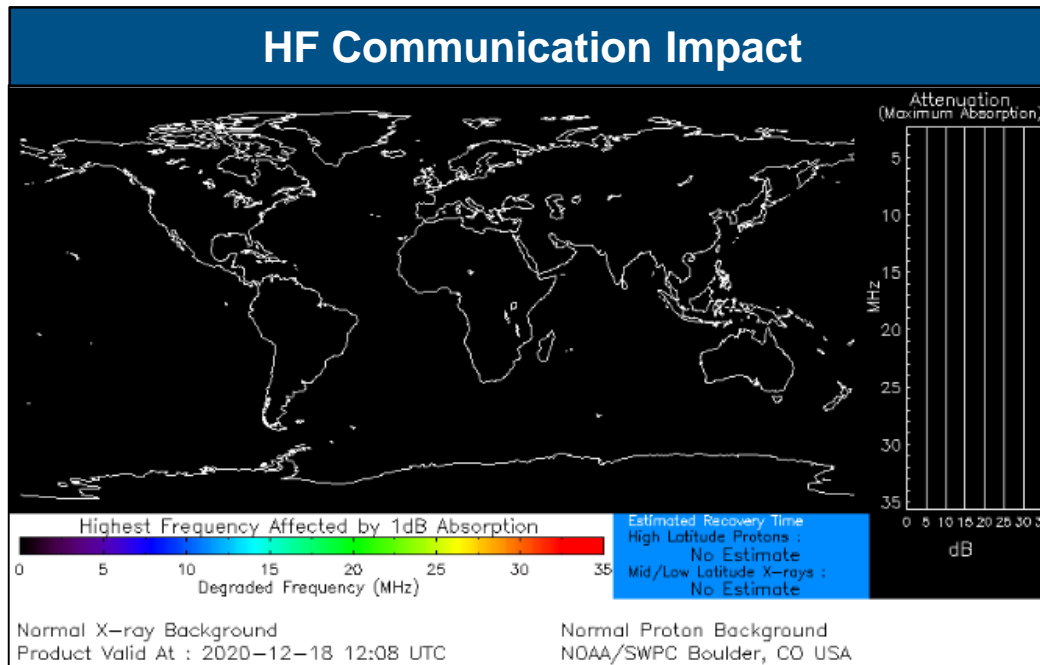

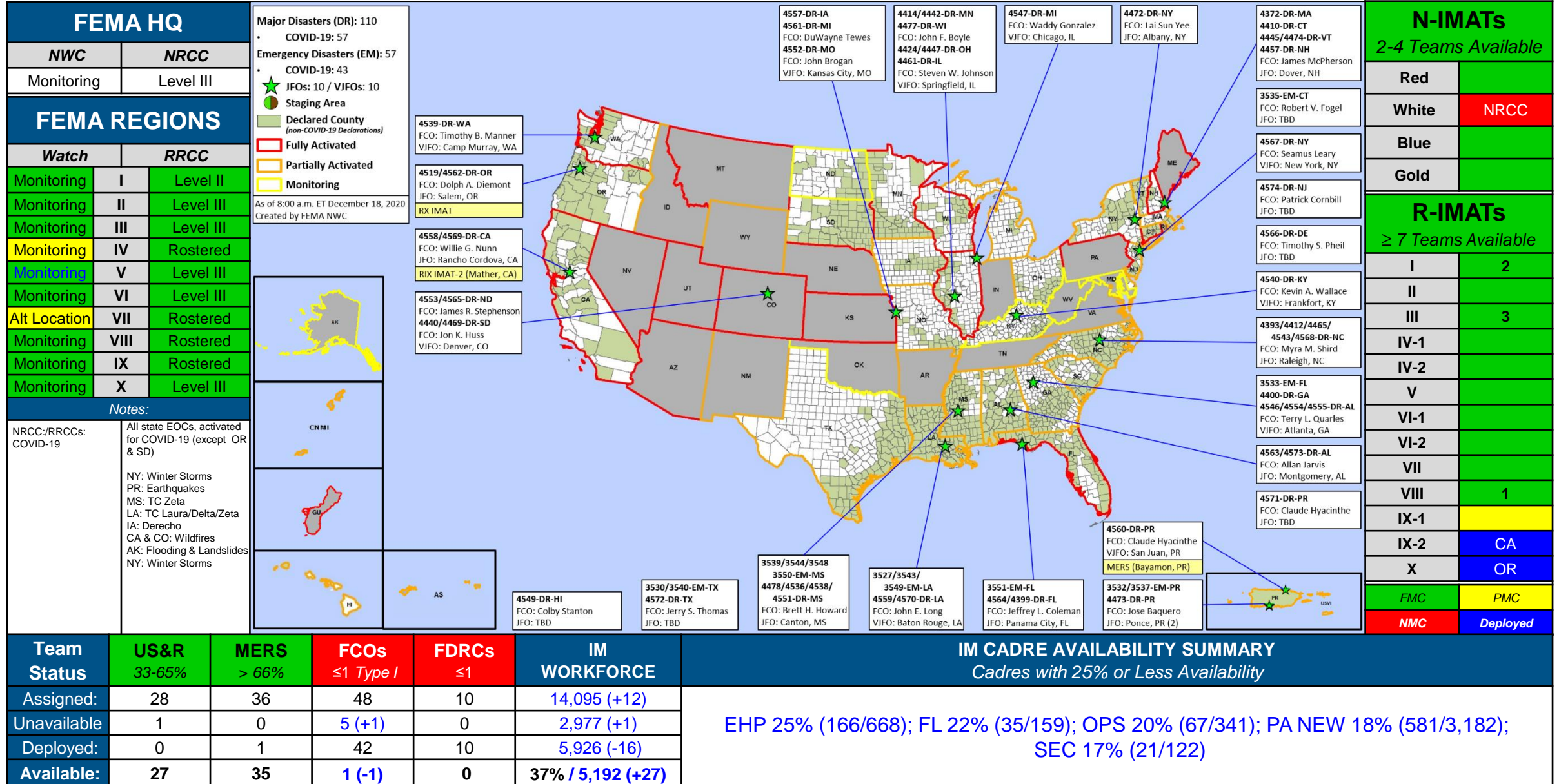
