

Lower Mississippi Flood Forecast





- Overtopping, levee breaches, and storage on the Arkansas River is causing less flow to make it into the lower Mississippi River. Crests heights were reduced ½ foot from Arkansas City, AR downstream to Natchez, MS. The Red & Ouachita Rivers continue to fall allowing more room for flows from the Mississippi River so crests on the Atchafalaya River were also reduced ½ foot and the crest dates brought in a few days earlier.
- The peak flow from the Arkansas River is expected to approach the lower Mississippi River in 1 week. This will cause rises of 1 to 2 feet for the second week of June. There is still uncertainty on the eventual peak flow/timing from the Arkansas River and how that will ultimately impact the lower Mississippi River.
- The Upper Mississippi River continues to rise and major flooding is occurring at Cape Girardeau, MO and Thebes, IL. Overtopping and levee breaches upstream are causing lower crests for both locations. Additional rises of 1 to 2 feet are expected over the next few days. This flood event will be similar to the May 2017 event.
- The flows from the Upper Mississippi River combined with more moderate rises on the Ohio River will cause Cairo, IL to crest at 47.5 ft on June 8th. This crest will be 9 feet lower than the previous flood in March 2019. This crest will approach the junction of the Arkansas River in a couple of weeks and fill in behind the crest from the Arkansas River.
- The Atchafalaya River will rise 1 to 3 feet over the next several weeks. Morgan City, LA is now forecast to crest at 9.5 feet for the third week of June. This would still be the 3rd highest crest on record and the highest since May 2011.
- Since the current river forecasts have been lowered by ½ foot, the USACE will evaluate the potential opening of the Morganza Floodway for Thursday, June 6th. If operated, this would be the third time that the floodway has opened with the last time being May 2011. Once the operation begins, Baton Rouge, LA downstream to New Orleans, LA will crest and remain at the same stage levels. The Bonnet Carré Floodway will continue to operate over the next month.
- The 16 day future rainfall guidance is showing rainfall of 2 to 5 inches over portions of Arkansas, Mississippi, Tennessee, and Missouri. The Lower Mississippi River could see slightly higher levels from Cairo, IL downstream to Helena, AR. Elevated stages would dampen the rise as it approaches the junction of the Arkansas River and elevated stages would remain for June and July.
- Based on the current 28 day river forecast, Greenville, MS will break the 1927 record of 115 consecutive days above flood stage within 1 ½ weeks. Other locations will continue to add to their records through June.









Precipitation Forecast


















Hazards Outlook – June 6 – 10







NPSC Call Forecasting and Actual Calls Over the Past 4 Weeks 5/5/2019 through 6/1/2019




