

# Tropical Cyclone Gita



- Tropical Cyclone Gita was located 261 miles SSE of Pago Pago; moving south at 17 mph, away from American Samoa; maximum sustained winds 55 mph
- Tropical Storm Warning cancelled but Flash Flood Watch, High Wind and Gale Warnings remain in effect
- American Samoa received 21 inches of rain last week, saturating the ground;
   Gita should bring additional 6-8 inches of rain; another system (Invest 98P)
   could bring even more rain
- Major threats are mudslides and high winds

#### Impacts:

- Fatalities / Injuries: No fatalities; 5 minor injuries
- Damages: Preliminary reports of 200 homes destroyed or with some type of roof damage
- Evacuations: Some homes evacuated due to flooding
- Shelters and Occupants: 5 shelters open with unknown number of occupants
- Power Outages: 60% of island without power; estimated 3-5 days to restore
- **Transportation:** Airports and seaports closed until further notice; some roads washed out or blocked by debris
- Communications: Intermittent telephone and cellular outages; no internet service




# **Precipitation Forecast**






## Winter Precipitation Outlook






Forecast Snowfall



Forecast Ice Accumulation


