**Tropical Activity:** No activity affecting U.S. interests

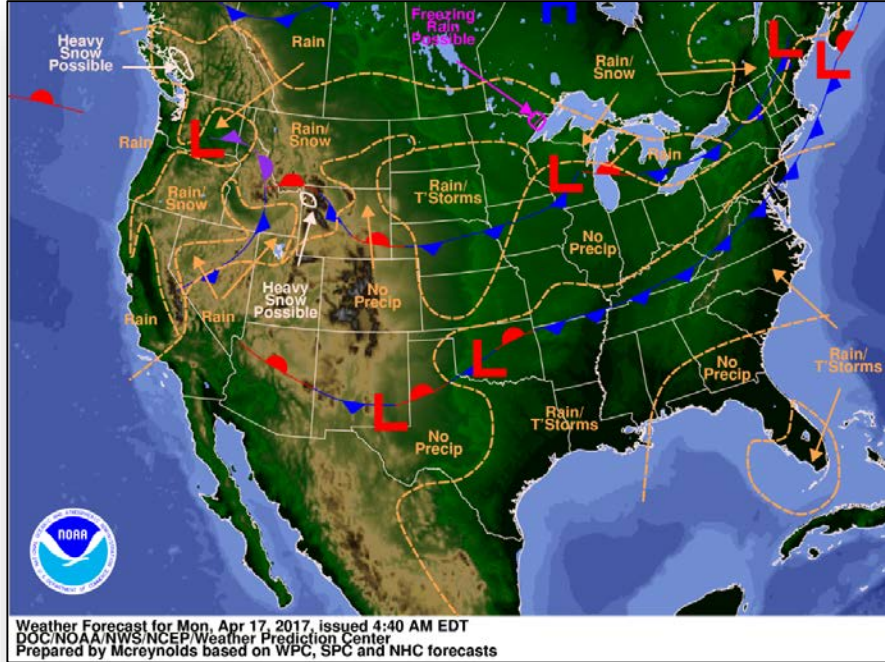

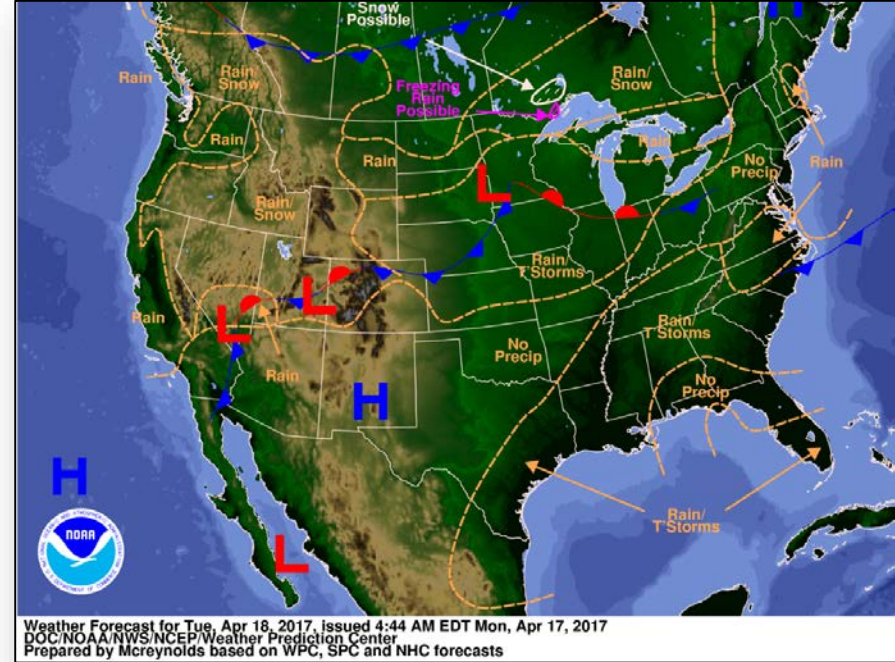

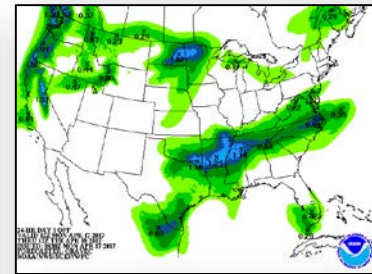

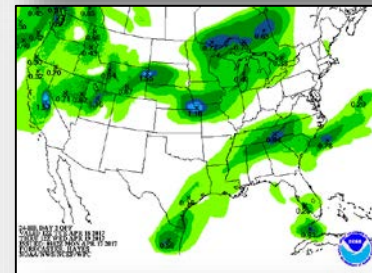
# Precipitation Forecast – Days 1-3



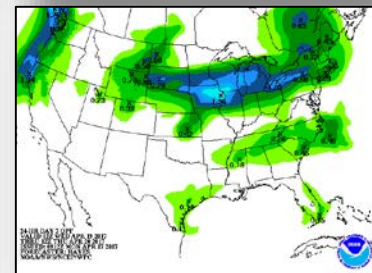

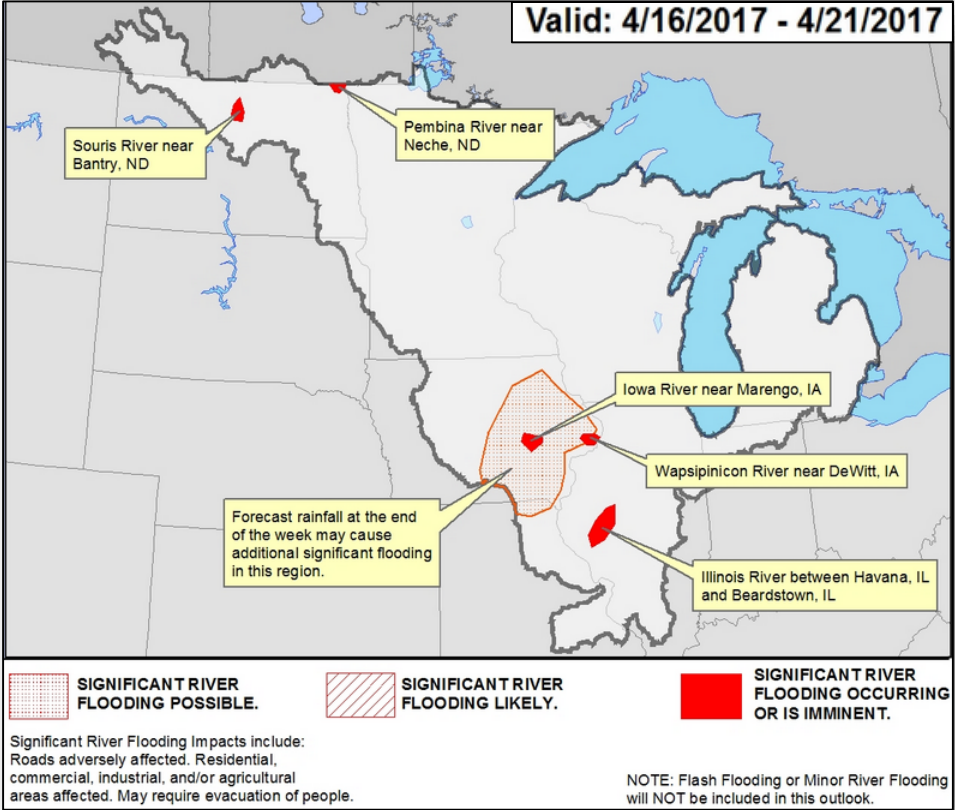

# Significant River Flood Outlook

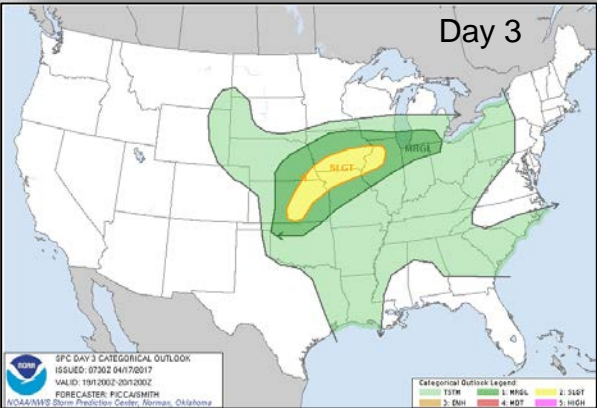
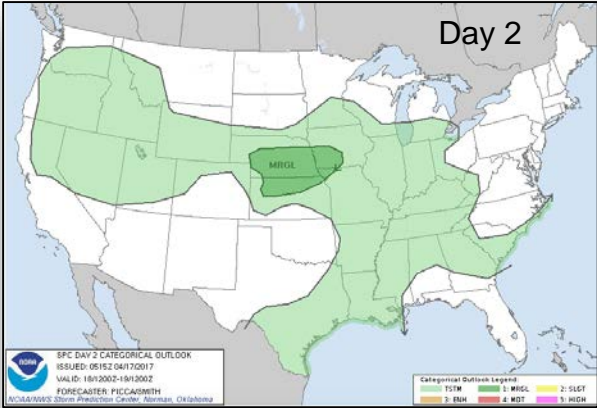
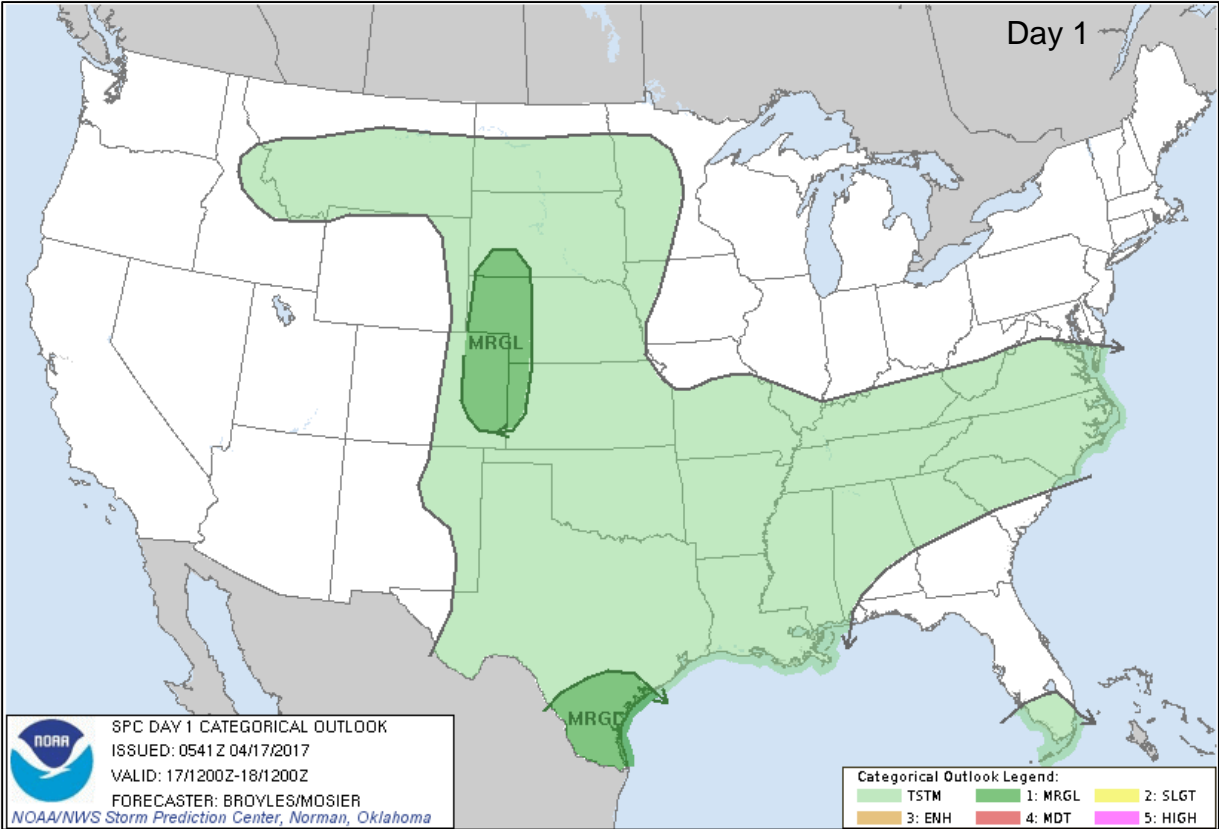

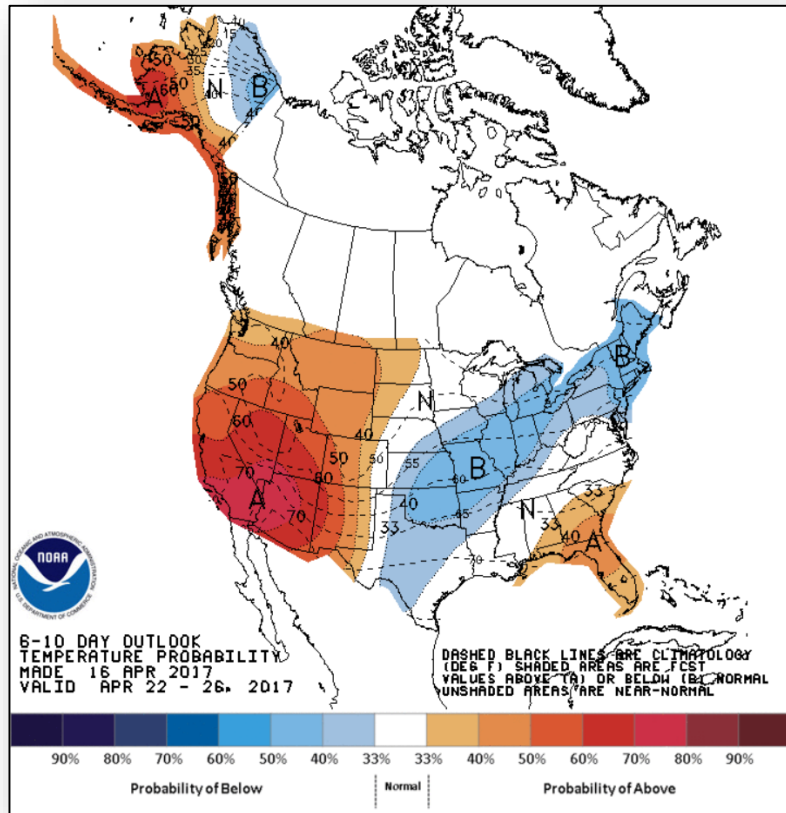
# Severe Weather Outlook – Days 1-3



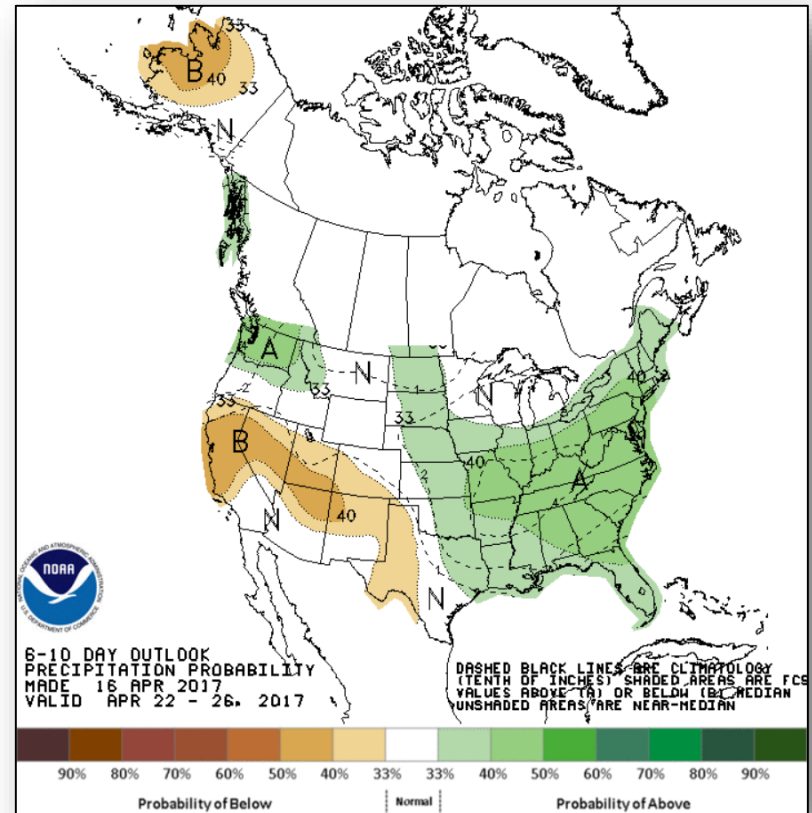
# 6-10 Day Outlooks

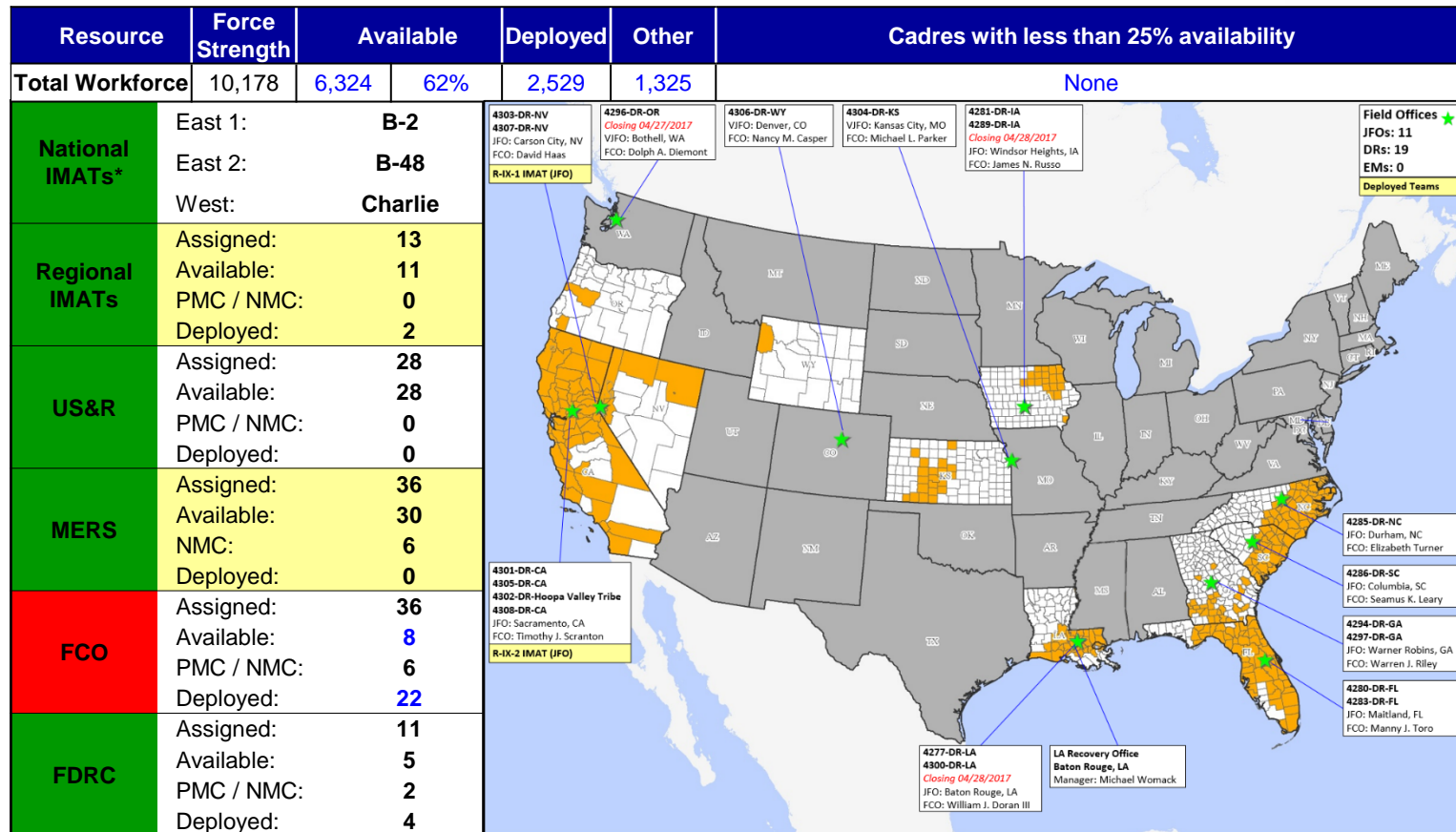
