Volcanic & seismic activity continues to increase in the Puna area. Threats include lava flow, steam, ash clouds, earthquakes, landslides, & fire. Lava & steam reached the surface of Leilani Estates in lower Puna on Thursday. Over 102 earthquakes of magnitude 2.5 or higher recorded in the last 7 days. USGS alert-level/aviation color code: WARNING/ORANGE (eruption imminent/underway)

Impacts


- Earthquake activity caused rockfalls, additional collapse into the Pu'u 'Ō'ō crater, a short-lived plume of ash, & numerous cracks in roads in/around Leilani Estates
- Residents of Leilani Estate & Lanipuna Gardens under mandatory evacuations
 - o All people in the Puna community are urged to evacuate
- · Two shelters open with unknown number of occupants
- FAA established Temporary Flight Restrictions (TFRs) around affected areas
- · Local schools closed as a precaution











Precipitation / Excessive Rainfall Forecast





Hazards Outlook – May 6-10







