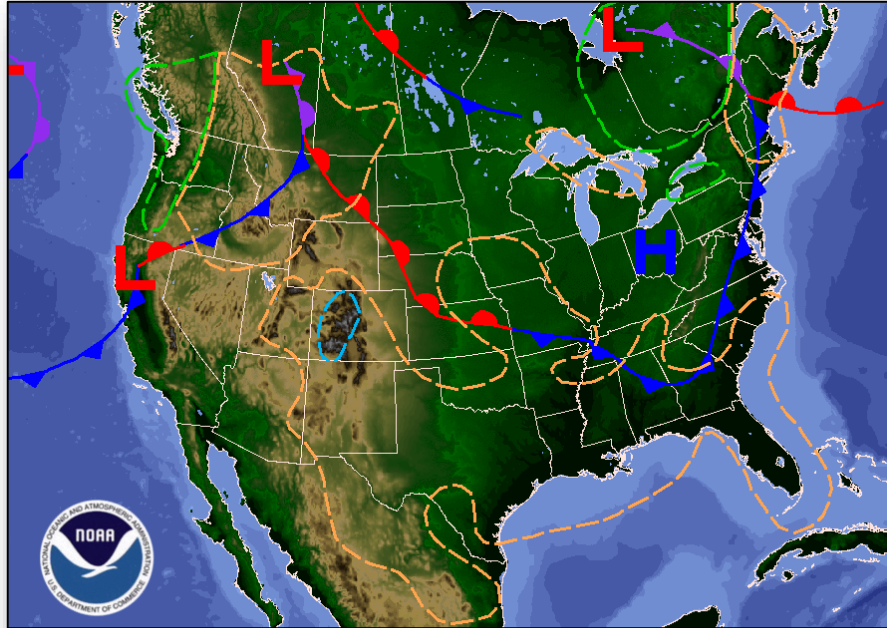
- Located 220 miles ESE of Acapulco, Mexico

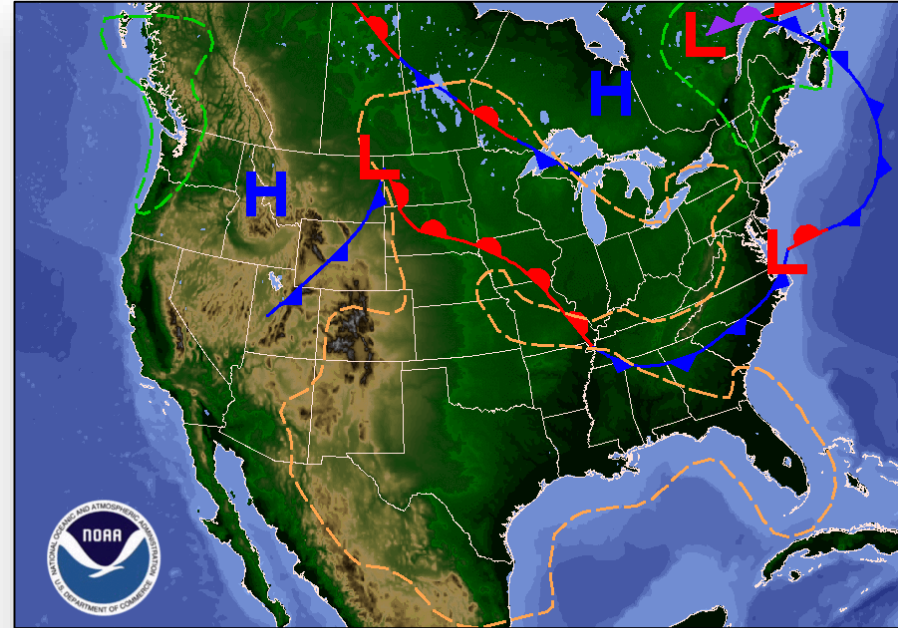
Day 1 National Forecast Chart

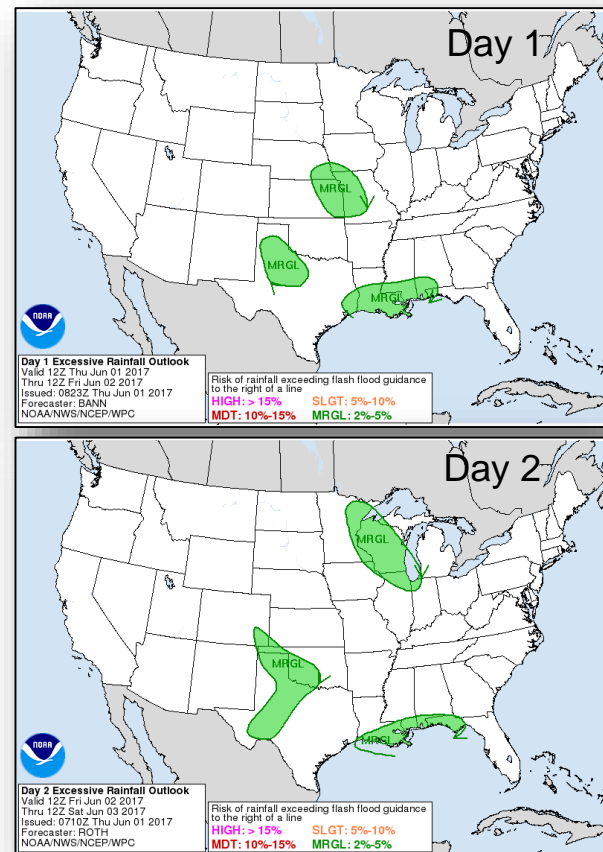
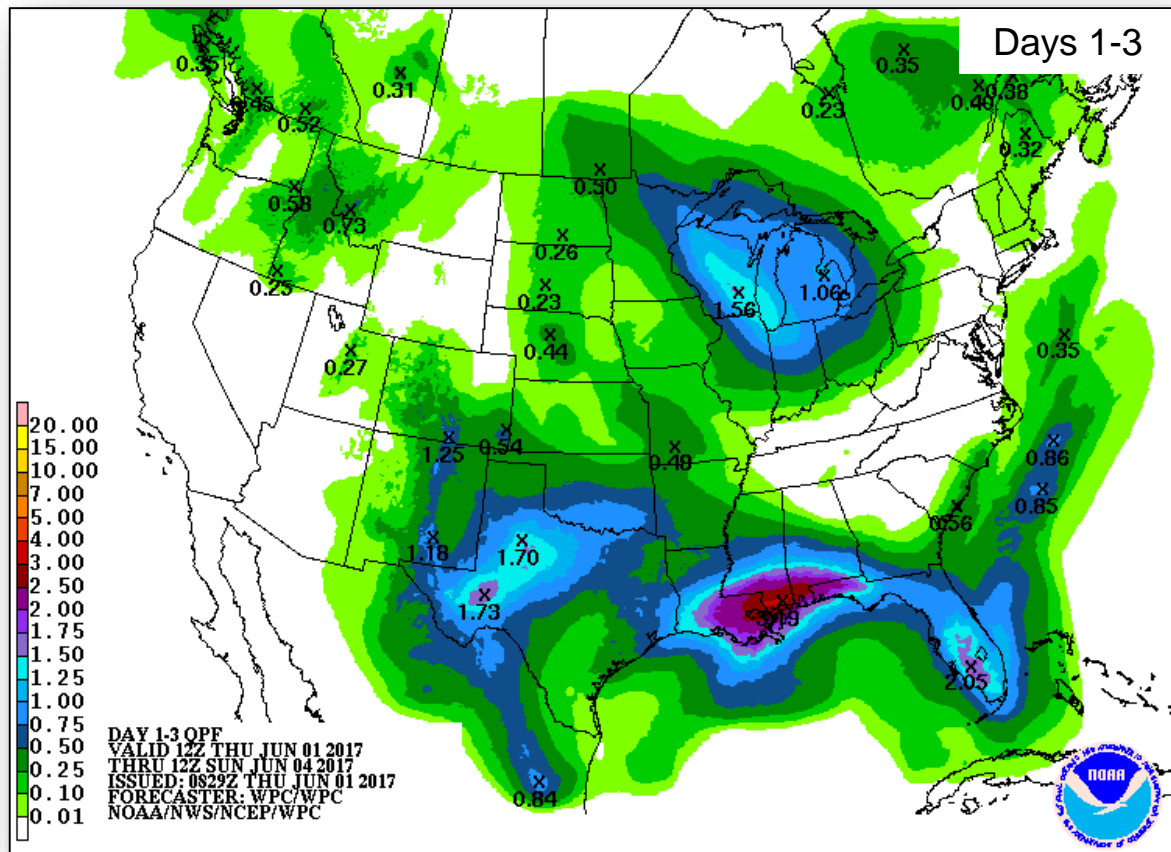

Precipitation Forecast / Flash Flood Risk



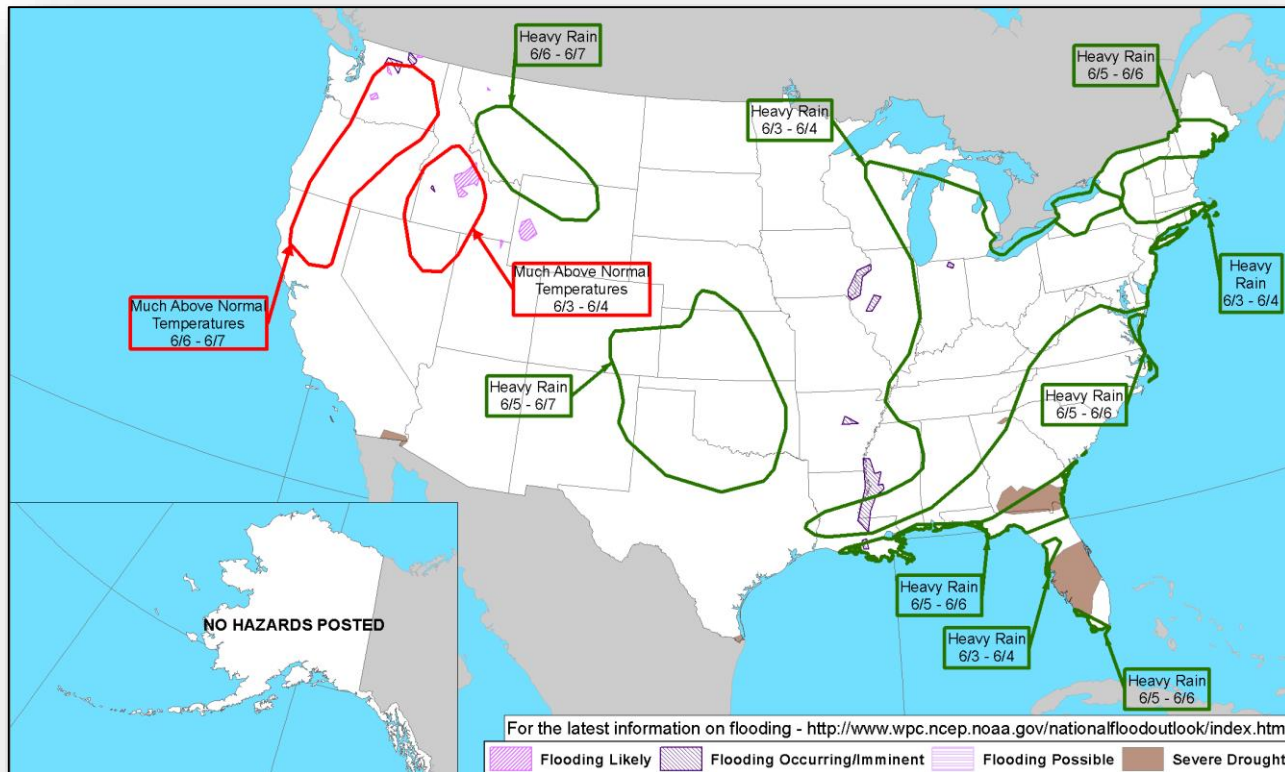

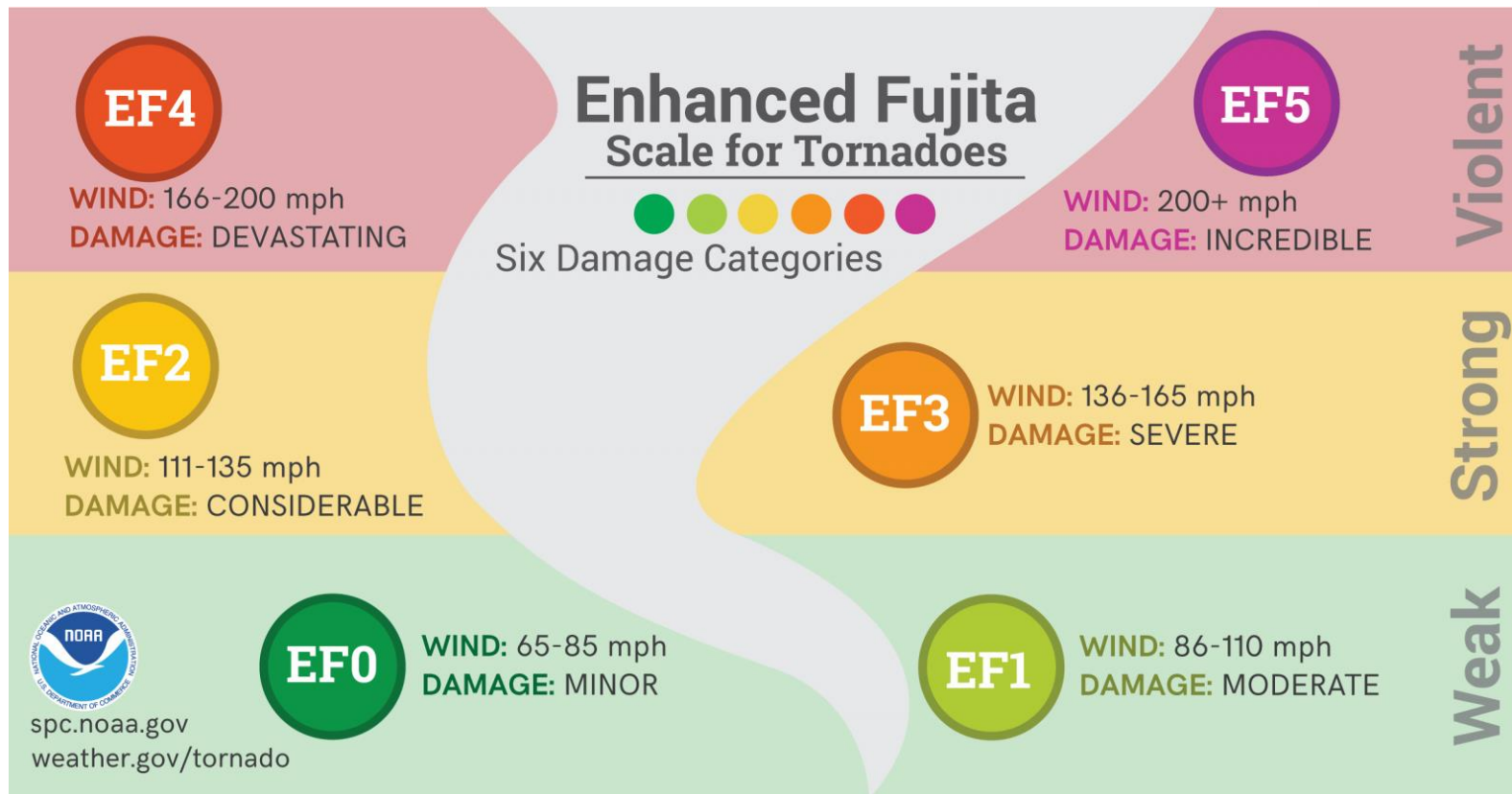

 - Hazard Mitigation statewide



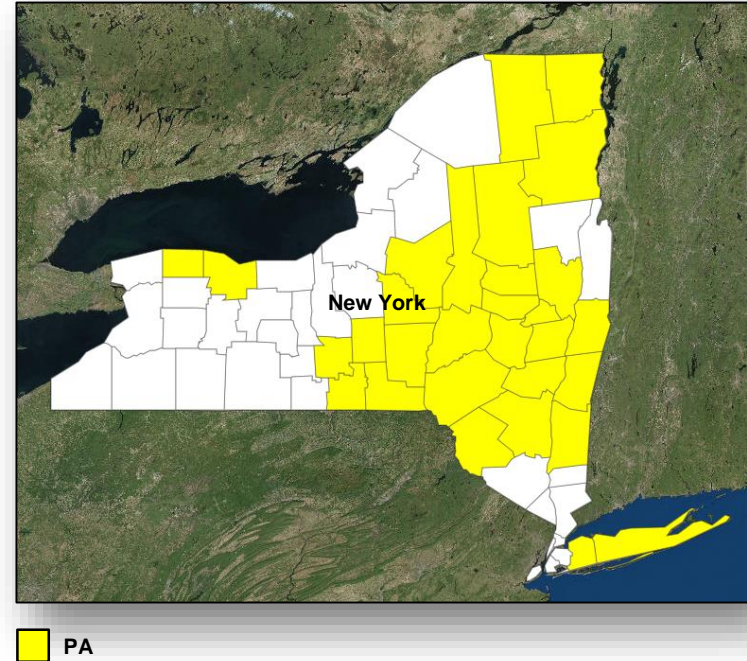
Declaration Request

- For severe winter storm and snowstorms that occurred March 14-17, 2017
- Requesting:
 - Public Assistance for 30* counties
 - Hazard Mitigation statewide
