- Atlantic – No tropical cyclone activity expected during the next 48 hours
- Eastern Pacific – No tropical cyclones expected during the next 48 hours
- Central Pacific – No tropical cyclones expected during the next 48 hours
- Western Pacific – No activity affecting U.S. interests

**Significant Weather:**

- Severe thunderstorms possible – Northern Rockies and Northern Plains
- Rain and thunderstorms – Pacific Northwest to Northern Plains; Southwest to Great Lakes; Southeast to Central Appalachians; Northeast
- Flash flooding possible – southern Florida
- Rain and snow – Northern Intermountain
- Red Flag Warnings – NV & UT

  - Next 24 hours: None predicted

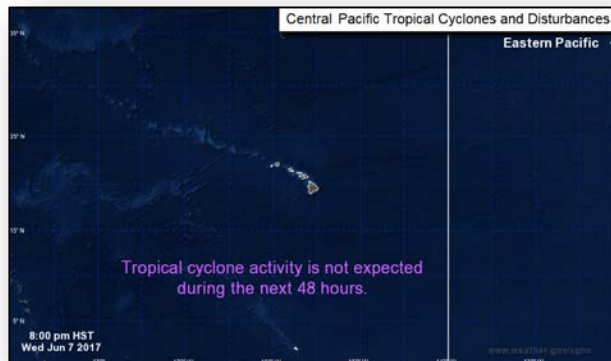

# Precipitation Forecast / Flash Flood Risk



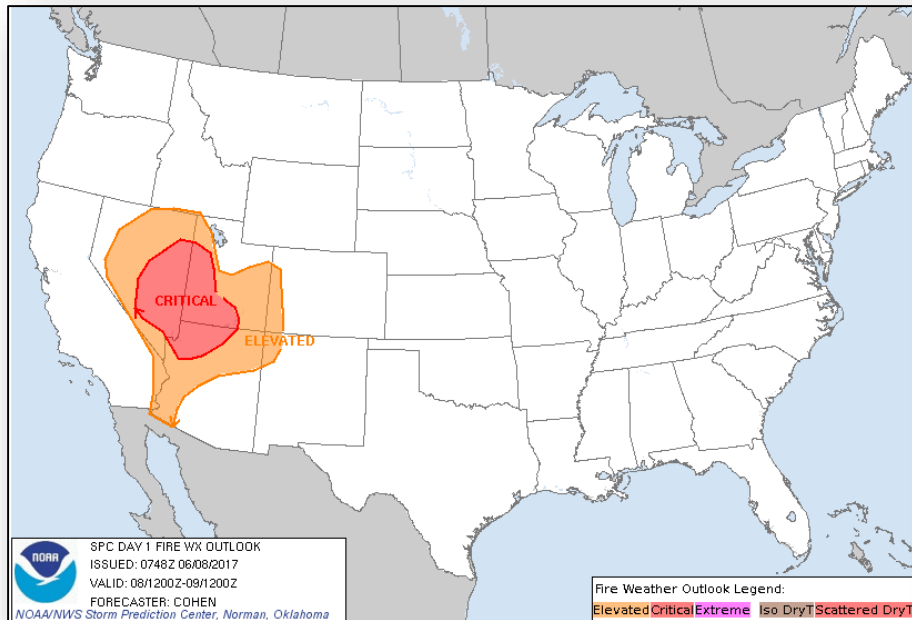

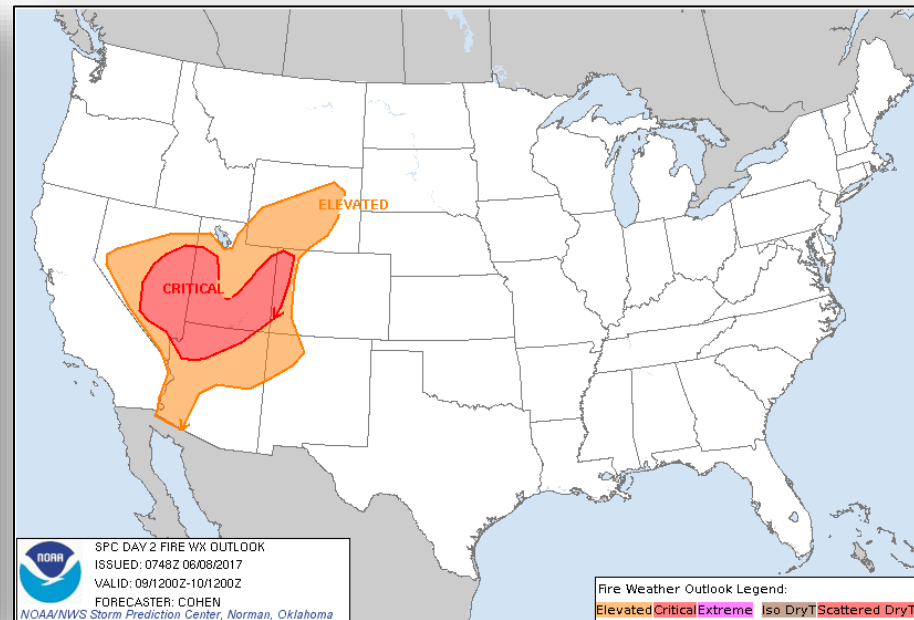
# Fire Weather Outlook

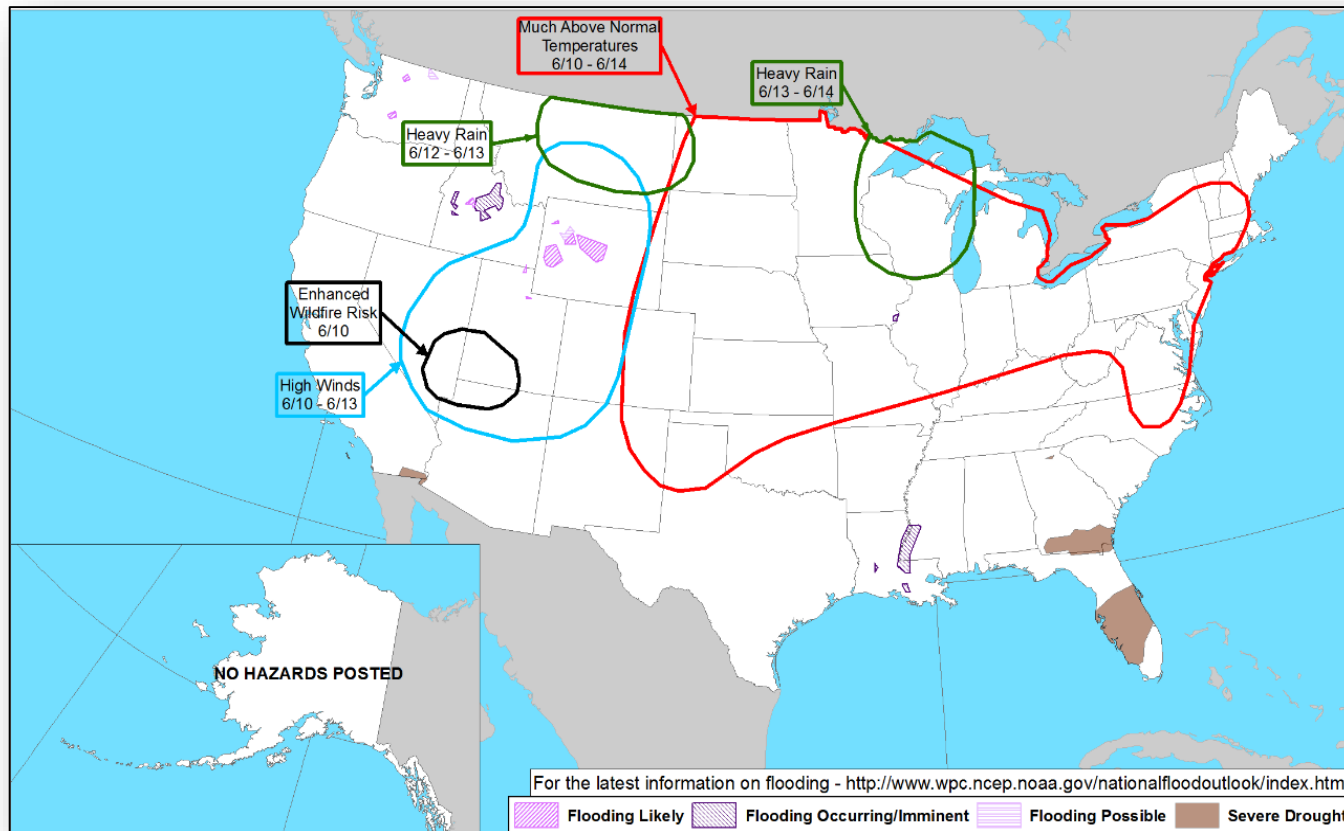

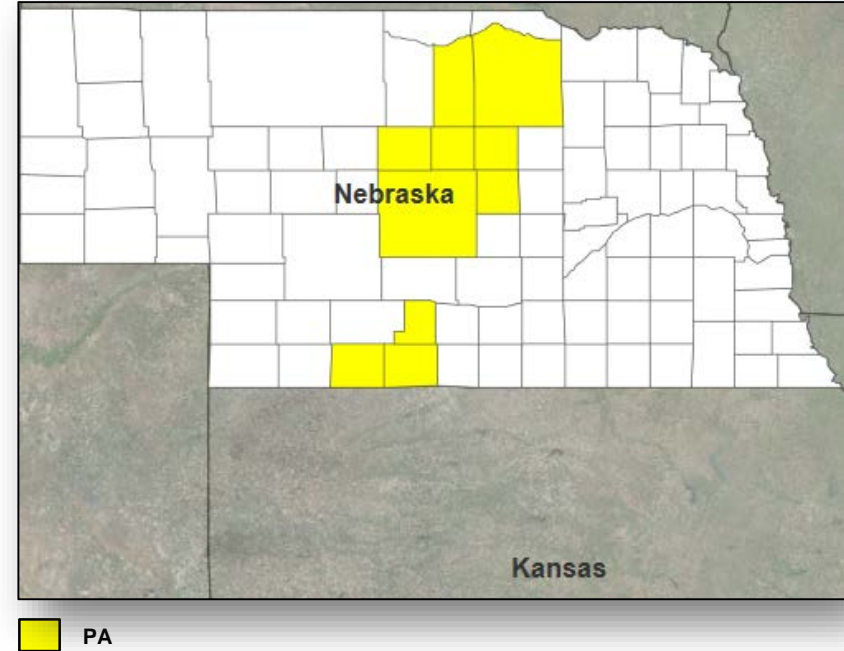
# Declaration Request

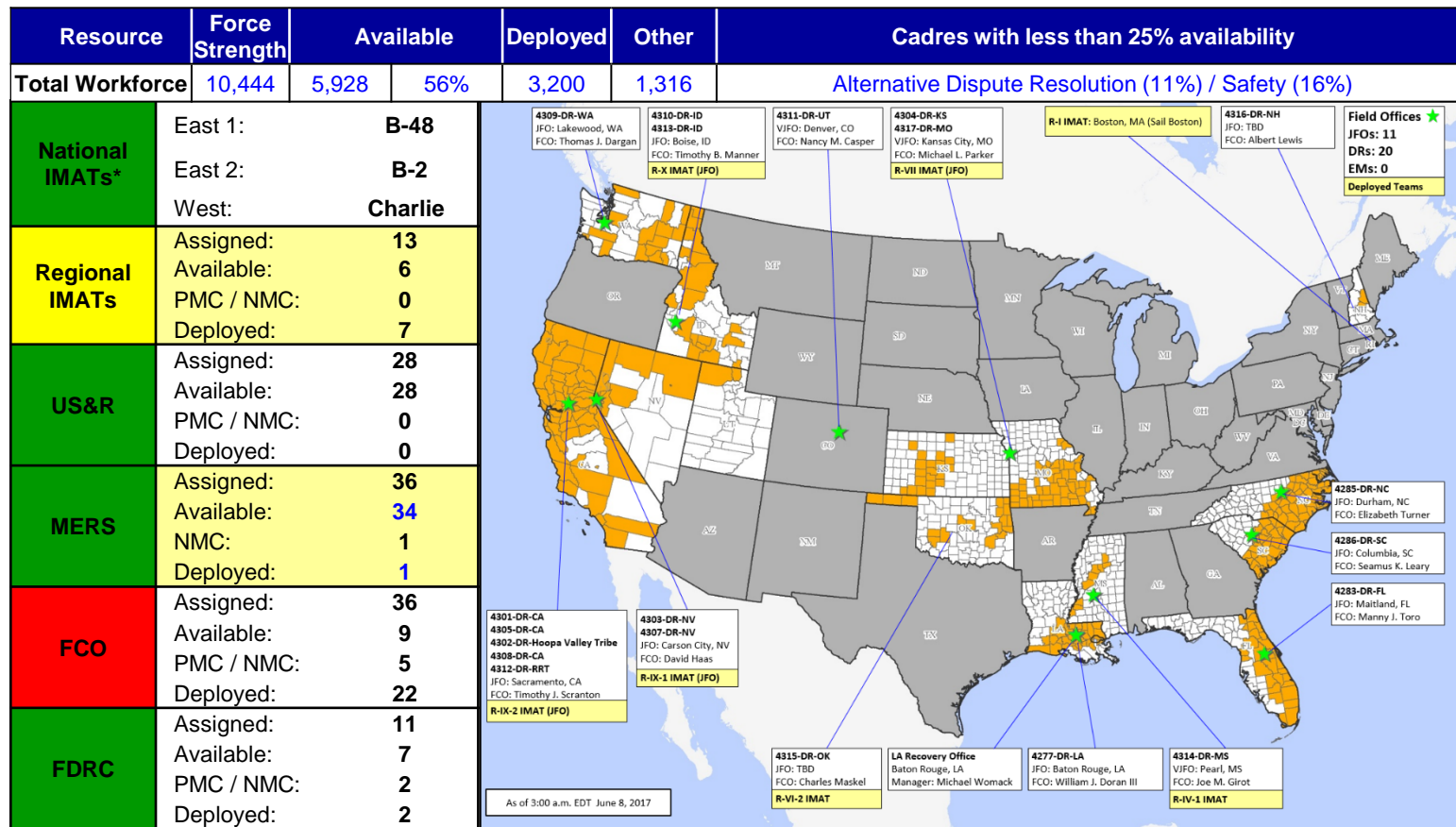
