



Tropical Outlook – Central Pacific






National Weather Forecast






Precipitation / Excessive Rainfall Forecast







Incident Overview


During the period of February 14 -25, 2018 Ohio received consistent heavy rainfall resulting from a series of storms across the Midwest. On February 24th severe storms brought heavy rain and high winds to southern and central Ohio. This resulted in flooding along the Ohio River watershed which affected numerous counties. Throughout the incident period Ohio experienced severe storms, Flooding, and Land Slides. This resulted in widespread heavy damage to public infrastructure. On February 18, Governor John R. Kasich executed the State Emergency Plan and on

February 24 declared a state of emergency for 18 counties in Ohio for both response to impacts and in preparation of additional forecasted impacts. On March 26, 2018 following Joint PDAs (3/12/18-3/16/18) Governor Kasich submitted a request for a Major Disaster Declaration for Public Assistance Categories A-G and hazard mitigation statewide.

On April 17, 2018 the President approved a Major Disaster Declaration for Ohio for Severe Storms, Flooding, and Landslides during the period of February 14-25, 2018. The declaration provides Public Assistance (PA) for 18 counties and Hazard Mitigation Grant Program (HMGP) statewide. Amendment #1, on May 25, 2018, added four counties to the declaration: Coshocton, Harrison, Jefferson, and Morgan.


