Lower East Rift Zone: Eruption of lava and gas from the lower East Rift Zone (LERZ) continues into its seventh week.





<u>Tropical Storm Daniel</u> (Advisory #6 as of 5:00 a.m. EDT)

- Located 535 miles WSW of southern tip of Baja California, Mexico
- Moving NNW at 10 mph; maximum sustained winds 45 mph
- Forecast to become a tropical depression by late tonight or early Tuesday morning; should become a remnant low by Tuesday night

- No threat to U.S.








Tropical Outlook – Central Pacific

Eastern Pacific Hurricane Threat



Minimal Threat to the West Coast

While it is quite rare for hurricanes in the Eastern Pacific to strike the U.S. mainland, the moisture associated with these systems can often contribute to flooding in the Western and Southwestern States.

Eastern Pacific storms can track westward into the Central Pacific and threaten Hawaii. On average this occurs almost once per year.

Why is it rare for a West Coast Hurricane strike?

Hurricanes in the northern hemisphere tend to move toward the west-northwest - away from the West Coast.


Ocean temperatures along the West Coast are cool, rarely warm enough to provide the energy necessary to sustain a hurricane.


The occasional hurricane that does track northward toward the U.S. encounters these cooler waters which quickly reduces the storm's strength. Historically the rare exception has occurred during a strong El Nino.




National Weather Forecast











Precipitation / Excessive Rainfall Forecast

















Fire Weather Outlook









