

- · Expected to degenerate into a remnant low by early Monday




Tropical Outlook – Eastern Pacific




Disturbance 1 (as of 8:00 a.m. EDT)

- Formation chance through 5 days: Medium (60%)




Tropical Outlook – Central Pacific






48 Hour Outlook



5 Day Outlook






