- Western Pacific: No activity affecting U.S. territories

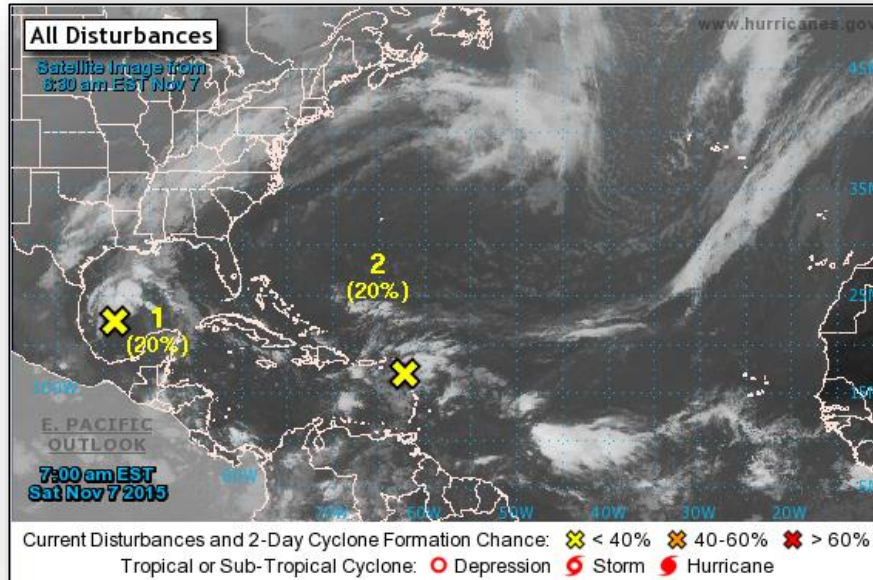
Significant Weather:

2 Day Tropical Outlook – Atlantic



Disturbance #1 *(as of 7:00 a.m. EST)*

- Concentrated showers and thunderstorms 300 miles SE of Brownsville, TX
- Some additional development possible the next 24 hours
- System is expected to merge with a cold front, making additional development unlikely
- Formation chance through 48 hours: Low, 20%
- Formation chance through 5 days: Low 20%

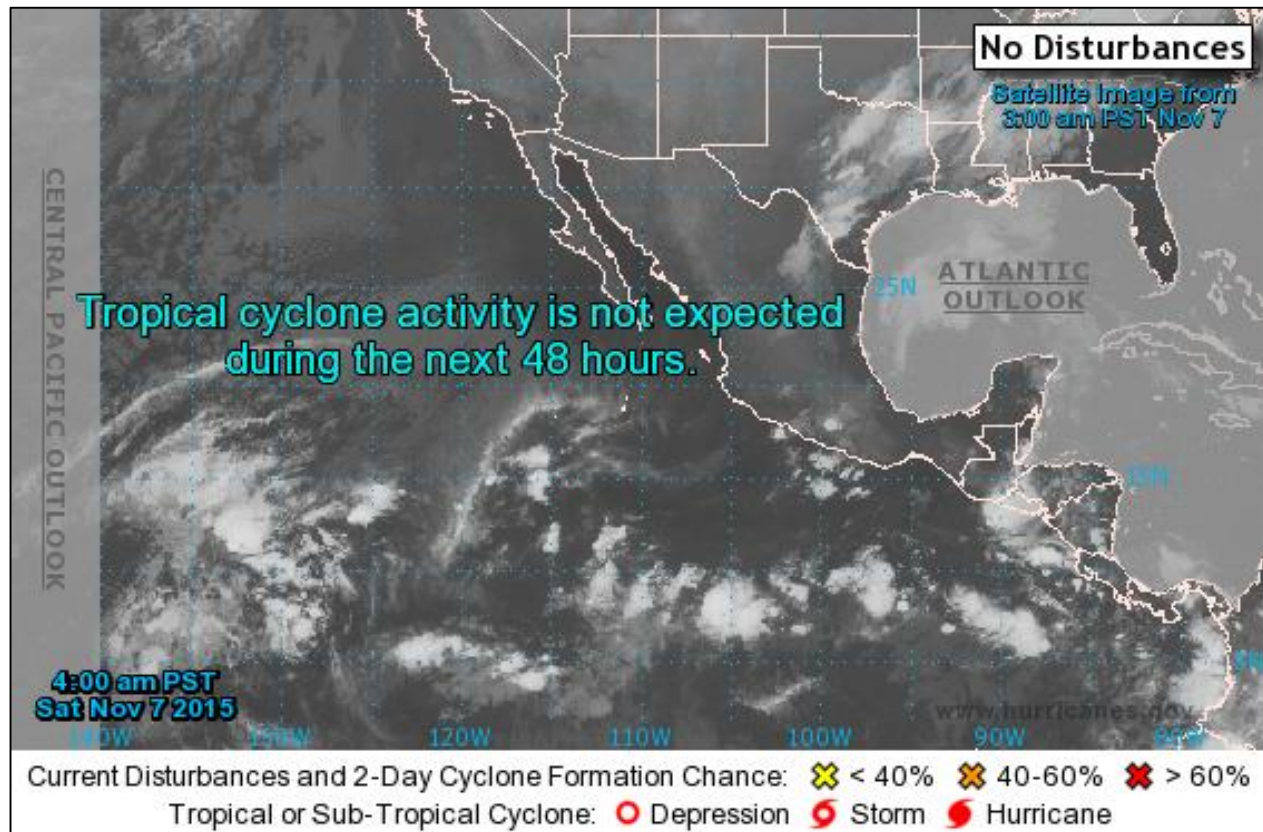
Disturbance #2 *(as of 7:00 a.m. EST)*

- Large area of cloudiness and showers from northeastern Caribbean Sea across the Lesser Antilles into the Atlantic
- Gradual development possible early next week, near or east of the Bahamas
- Locally heavy rains possible over the Lesser Antilles, Virgin Islands and Puerto Rico next few days
- Formation chance through 48 hours: Low, 20%
- Formation chance through 5 days: Medium, 50%

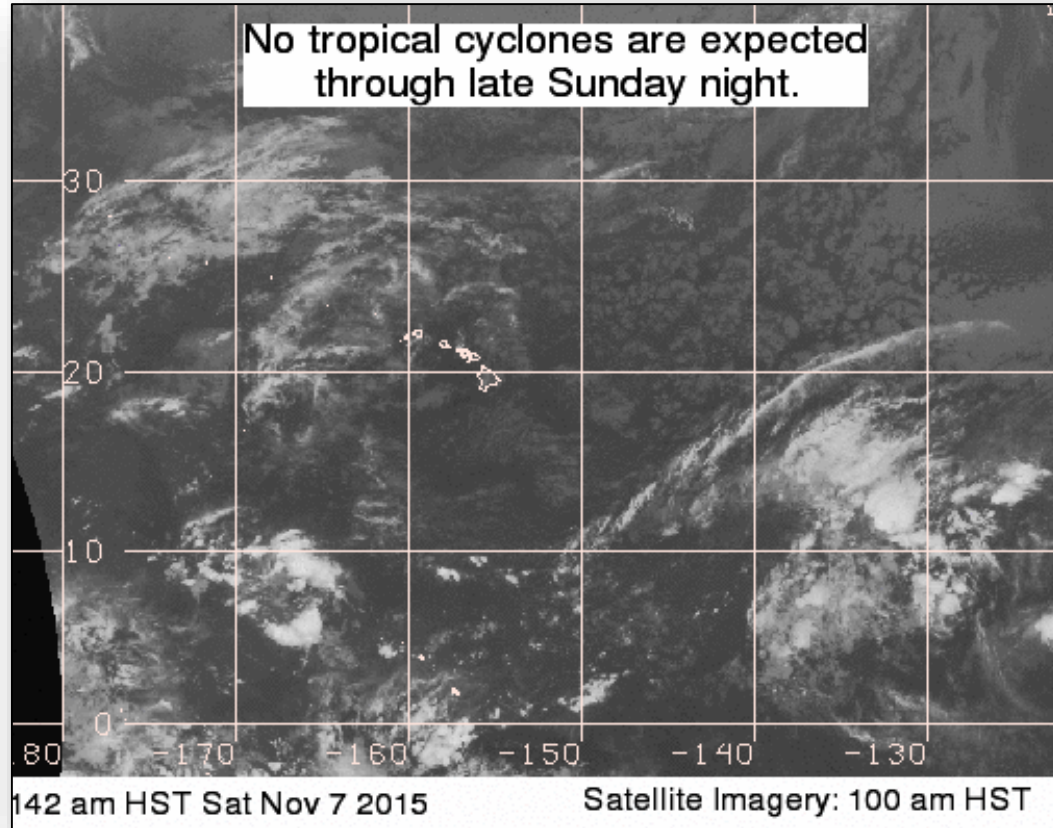
2 Day Tropical Outlook – Eastern Pacific



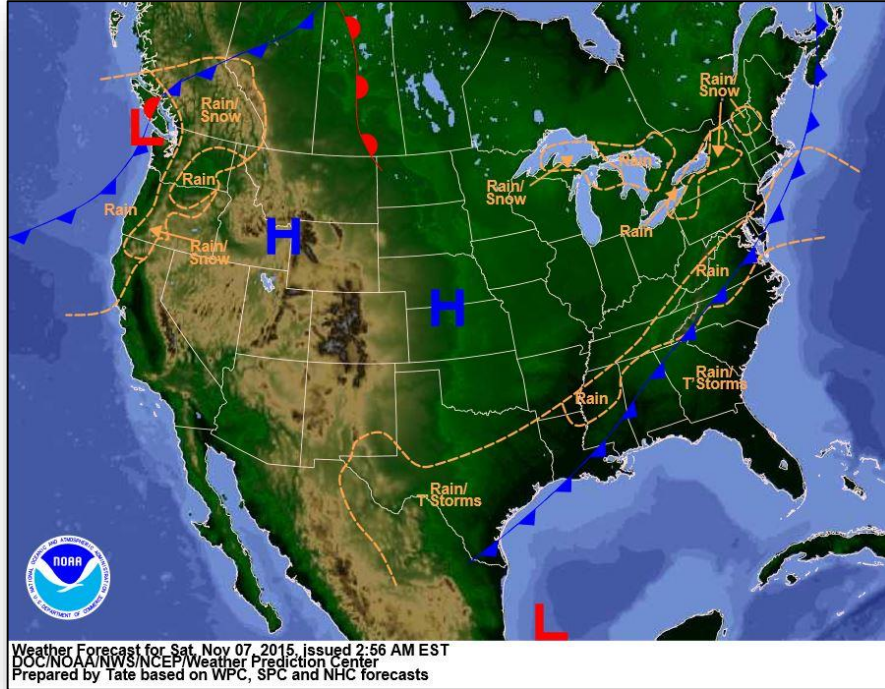

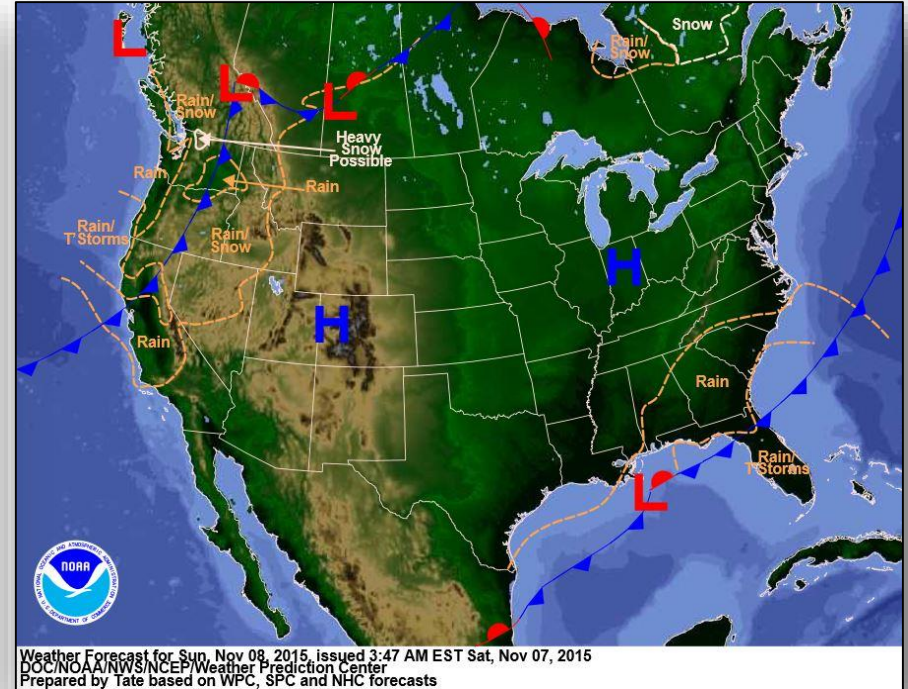
2 Day Tropical Outlook – Central Pacific

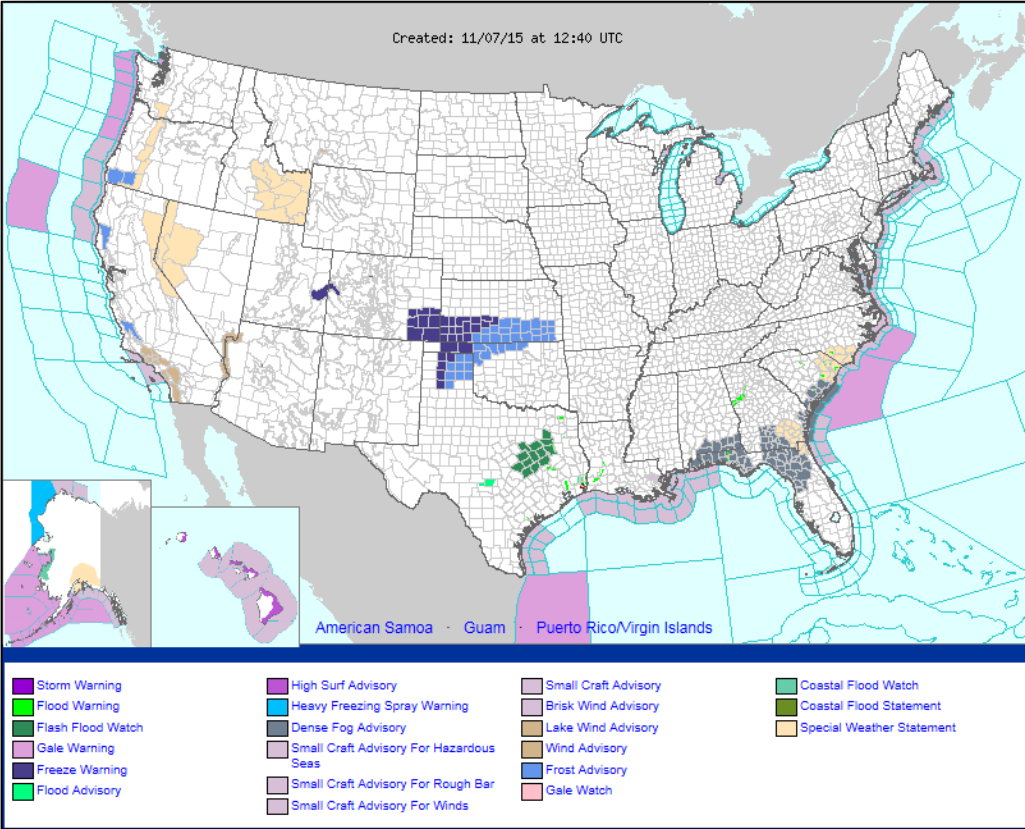

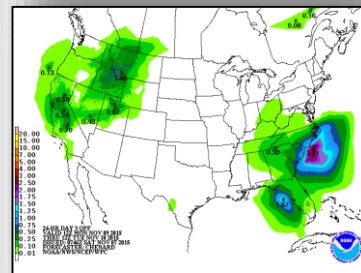
Precipitation Forecast, 1-3 Day

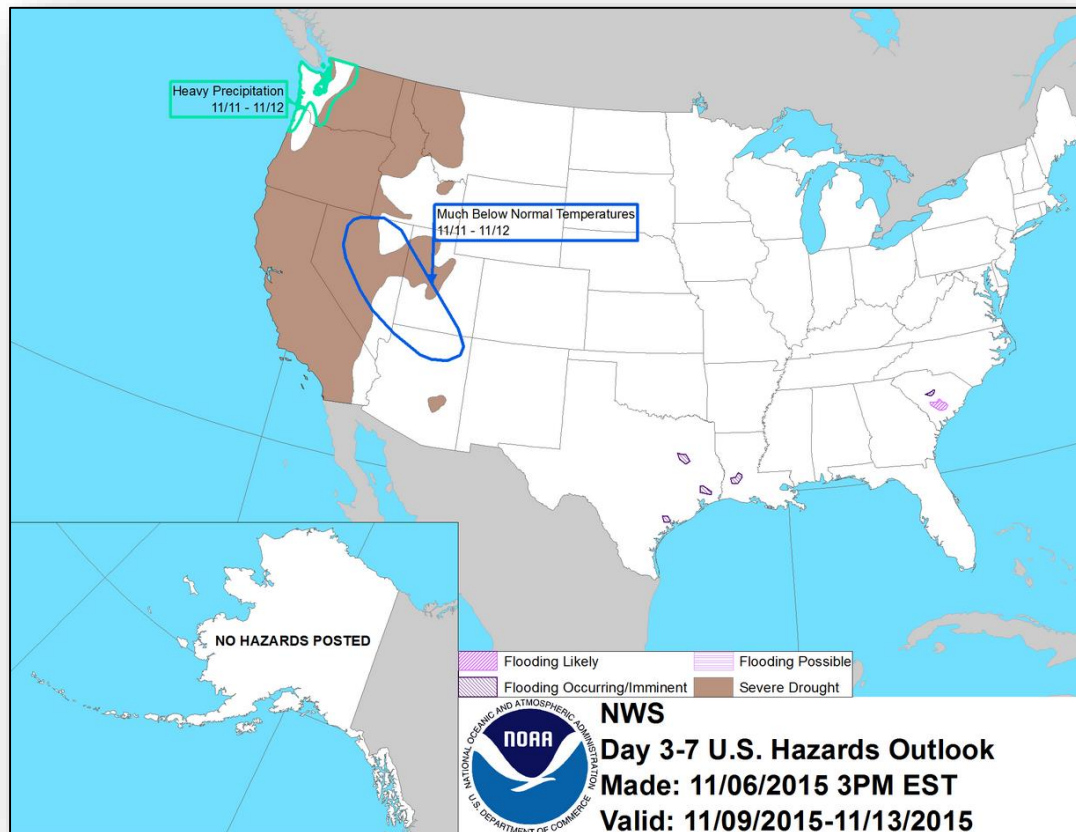

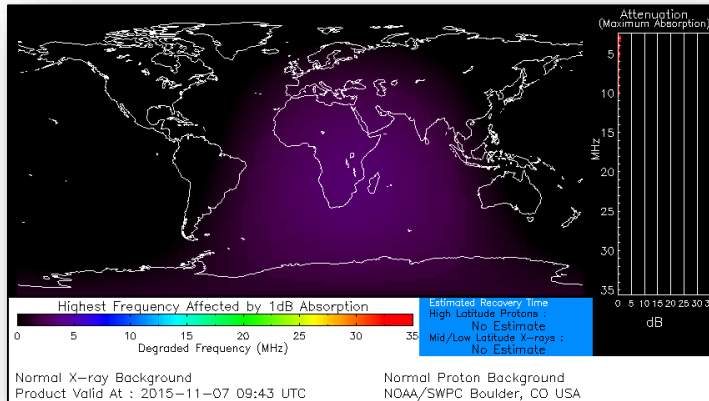

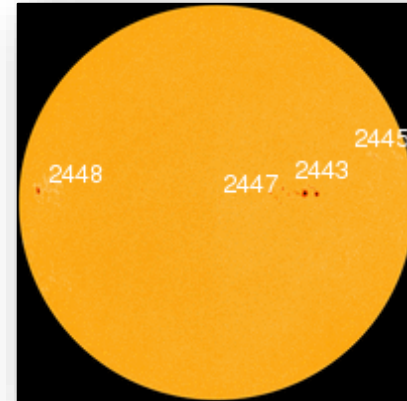

Sunspot Activity

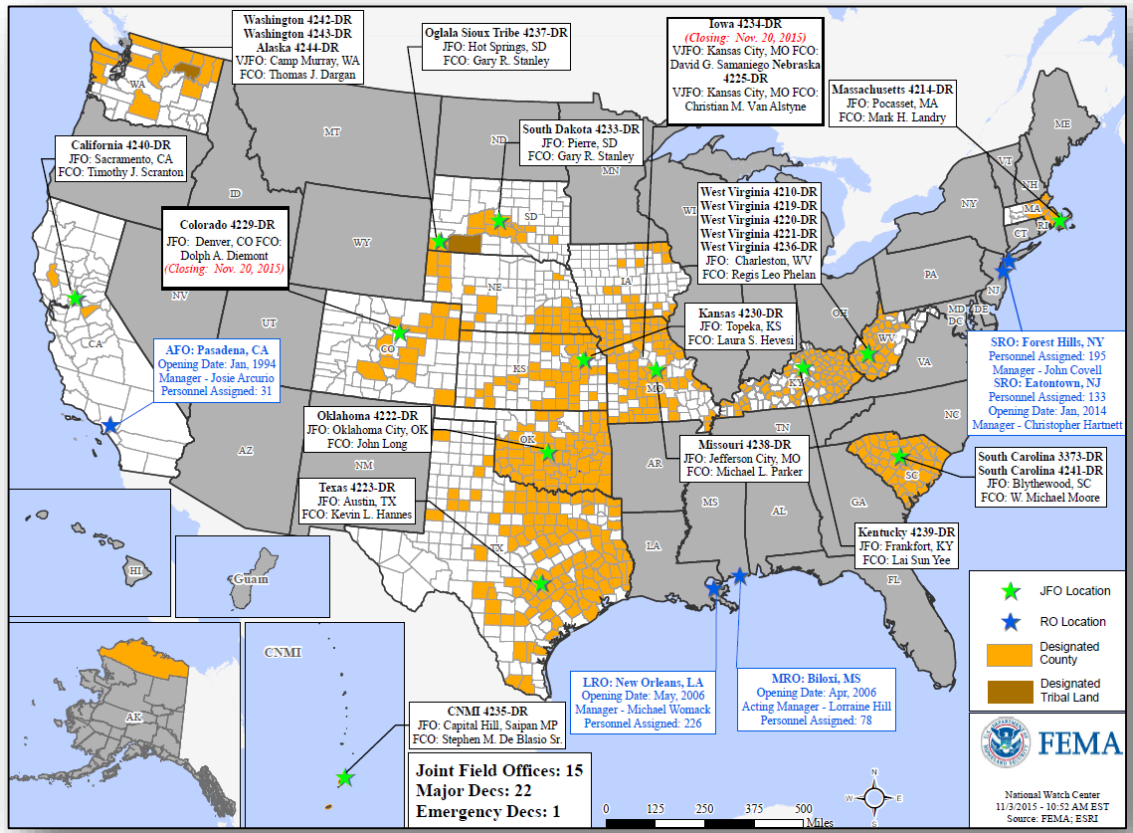
